Respected Sir,

I, Smt. Riya Paul, wife of Sri. Manotosh Sarkar, resident of Matangini Hajara Colony, Tikiapara, P.S. & P.O. Siliguri, Dist. Darjeeling -734006 and presently residing at Matigara, Anil Nagar, Chowrangi More, P.O. & P.S. Matigara, Dist. Darjeeling -734010, in the state of West Bengal, would like to bring the following facts regarding a notorious attack on my husband (Sri. Monotoah Sarakar) by one Raghu Nath Debnath, son of Late Ramanath Debnath during the Ganapati Virsarjan ceremony held at Mahananda Niranjan Ghat at around 10:30 P.M. on 24/09/2023 into your kind knowledge for necessary action-

1. That on 24/09/2023 at about 10:30 P.M. during the Ganapati Virsarjan ceremony held at Mahananda Niranjan Ghat which come under Your jurisdiction, as my husband (Sri. Monotoah Sarakar) was gathered to bid a heartfelt farewell to our Ganapati, therein my husband became the victim of a shocking and unprovoked assault. A visibly individual, later identified as Raghu Nath Debnath, son of Late Ramanath Debnath recklessly smacked a stone on my husband's head badly, causing severe injuries to him. Subsequently, said Raghu Nath Debnath alongwith 2-3 people again physically attacked him and bitten him on his arm, which further added to grievous hurt to his head, body and limb. Thereafter Bipul Ghosh and Anil Kumar Prasad friends of my husband somehow manage to restrain them. And they are continuously threatened my husband with abusive languages that they will not hesitate to shed blood or goes beyond that by killing of my husband and his family members so better keep your mouth shut and stay silent.

2. That my husband sustained a serious head injury that necessitated immediate medical attention. Accordingly, said Bipul Ghosh and Anil Kumar Prasad rushed and took him to Siliguri District Hospital where he was admitted and received treatment for his critical injuries. The injuries include a deep head wound that required stitches, bite wound on his arm and several undisplay injuries on his body caused internal pain. Consequently, today was discharged by the concerned Hospital authority in which it is clearly mentioned that it is case of Physical Assault subject to Police Case that I have enclosed herewith for evidentiary purposes.

A photocopy of the Discharge Certificate of my husband issued by the Department of Health and Family Welfare Government of West Bengal is enclosed herewith this FIR for your reference.

- 3. That thereafter my husband received a phone call from the said Raghu Nath Debnath being Mobile No. +91 7908489667 that quickly escalated into highly offensive and abusive language directed towards my husband and proceeded to make explicit threats to his safety and his family members. In case my husband has all the phone call recordings which are kept in his custody if required I can provide for your ready references.
- 4. That in such a situation we are suffering from extreme insecurity, anxious, fearful, and concerned for my safety of my husband's life and our family since said Raghu Nath Debnath is rootless and very aggressive in nature, abusing and threatening my husband and our family members with dire consequences. Therefore, I urgently request you to take immediate action against Raghu Nath Debnath, son of Late Ramanath Debnath in accordance with the law to ensure justice is served. We are fully prepared to cooperate with the police investigation, providing any additional information or assistance necessary.

Under the above facts and circumstances you are requested kindly to look into the matter and to investigate on an urgent basis to ensure safety, security of my husband's life and our family members and to ensure punishment of the said Raghu Nath Debnath.
