with due respect, I, the undersigned namely,
Smt. Khushboo Shah, w/o, Sri, Nivek Shah, resident
of Ashranpara, Siliguri, Dist - Darjeeling, would like to
state as follows :

(i) That today around 5 pm, when my husband namely
Nivek Shah, went for collection of money for the
good delivered today at "The Glass India" having
his business place / shop situated at Bidhan Road,
opp. Royal Glass House, Near Hotel Raj, Siliguri.
The owners of the shop "The Glass India" identified
as Biswanath Dutta and Biswanath Dutta started
using filthy language as soon as my husband
went into their premises asking for money.

(ii) Further, both the owners of the shop started
using fits and ran from their shop. As my husband
caught them again at Bidhan Road, Traffic point,
the two brothers started using filthy language,
and pushed him on road, dragging him to the
bamboo pole nearby, thrashing his head severely.
Hence, my husband was severely injured, as presently
admitted at, Siliguri District Hospital, fighting death.

(iii) Hereafter, when I requested them to stop and
safeguard my husband, they assaulted me physically
and used the same bamboo pole to bang my head.
They have also snatched my gold chain weighing 15 gm.

(iv) I, hereby request the concerned authority to safeguard
our life from the culprits and take immediate action as
they have also threatened me of worse consequences on
approaching any local police station or authority.
