Subject: F.I.R

Sir,

With due respect in producing herewith one seized vehicle bearing Reg. No. WB 57 E 8047 (Trucktor) loaded with river bed materials, I PSI Arindam Saha of Matigara P.S, SPC lodge this Complaint against the driver/owner of the vehicle bearing Reg No- WB 57 E 8047 to the effect that on 27.09.2023 at 08:30 hrs onwards in course of Mobile van duty I received a specific information that illegal mining is going on at Rakti River and transporting by a vehicle bearing Reg. no. WB 57 E 8047. Accordingly myself along with force went to the Rakti River near Fulbari Ghat under Matigar PS, SPC and found that one vehicle bearing Reg. No WB 57 E 8047 loaded with riverbed materials was coming from Rakti River near Fulbari Patan Bridge towards Khaprail Road. I signalled the driver to stop the vehicle but after stopping the vehicle driver fled away leaving behind the loaded vehicle. Then I tried to search the driver/owner of the vehicle but in vein. Then I seized the vehicle bearing Reg. No. WB 57 E 8047 under proper seizure list after observing all formalities. Seizure was made between 09:05 hrs to 09:25 hrs and brought the vehicle at PS compound

Therefore I pray before you a specific case may kindly be started against the driver /owner of the vehicle bearing Reg. No. WB 57 E 8047 for illegal mining and transporting of riverbed materials, under proper section of law and arrange for its investigation.
