With due respect I Sri. Ram Naresh Sahani, S/o Ramakul Sahani, R/o Champasari, Auto Stand, Samar Nagar, P.S. Pradhan Nagar, Dist:- Darjeeling, would like to draw your kind attention towards the following effect that on 25.09.2023 at about 10:45 P.M. my brother-In-Law namely Chandan Sahani, S/o Lt. Lal Babu Sahani, Durgaguri, Ward No: 45, Under P.S. Pradhan Nagar, Dist.: Darjeeling, along with 1 [one] Sonu employ of him visited Zaika Biryani Hub situated at Burdwan Road, Siliguri, for their dinner but suddenly one phone call was came in the phone of my Brother -In-Law, due to network problem, my said Brother-In-Law came out of the said Biryani Hub and was standing in front of the said Biryani Hub, and to talk with his wife at that time the aforesaid persons attacked my said Brother- In-Law with an iron rod and hit with the said iron rod in the middle part of the head with the intention to kill him with full knowledge that act may cause death of him as a result, who sustained severe head injury and blood was oozing and the people standing there on gathered there for which the aforesaid persons fled from their thinking that he may die but with the help of persons present there my said Brother -In-Law rescued/entered into the said Biryani Hub and probably the manager of the said biryani Hub called the police and subsequently police came their and took my brother in law in Siliguri District Hospital, along with Sonu, therein the attending doctor treated him and got 5 [Five] number of Stitches in his head. At that point of time I along with another three four persons reached there and subsequently admitted / shifted my Brother -In-Law to North Bengal Medica, P.S. Pradhan Nagar, for his seriousness wherein his further treatment is going on till now. The entire incident of the said incident has been recorded in the CC.TV Surveillance of the said Biryani Hub, so it is very much crucial to preserve the said recordings of the incident in order to prevail the truth to the utmost importance. It is pertinent to mention that on 19.09.2023 at about 12:30 A.M. aforesaid three persons [SL.1-3] were roaming in a scooty in the locality of my said Brother-In-Law with their illegal motive, on the eve of Biswa karma Puja some

So, it seems to me for this reason the aforesaid persons attacked my brother-in-law to kill him.

Some unintentional delay has appeared to lodge this complaint due to the Medico logical of my said Brother-In-Law.

In the view you are request to kindly look into the matter and book the above-named culprits after initiating a specific case against them and also punish them as per law.
