Dear Sir,

I Doman Ram s/o Tilo Ram aged about 41 years resident  
of Kulipara, ward No. 1, Rajendra Nagar, below Railway bridge  
P.O. P.S. Pradhan Nagar, Dist Darjeeling would like to inform  
you that about 6 pm on 29.9.2023, I was plastering the  
area of my house as the rain water accumulates, the  
above-named persons suddenly started punching me and abused  
me and all of them attacked me with an intention to  
kill me. I got punched at my nose, and started bleeding  
very heavily and when my minor son and daughter came  
to rescue me they assaulted my daughter and son too.  
I have a very serious injury on my ear and my  
nose is broken as the bleeding is not stopping. They  
even admitted that they will kill me.

I therefore would request you to take proper legal  
action against these culprits at the earliest.
