Bhaktinagar, District- Jalpaiguri, West Bengal. On 21/09/2023, one truck vide no. AS-17C-7064 had been sent at about 09:00 pm from our branch office situated at 2nd Mile, Siliguri, by loading several materials (cloths and other items) to our other branch office situated at Bilashipara, Assam.

It is to be mention here that said truck vide no. AS-17C-7064 reached at about 6:00 am on 22/09/2023 at Branch office, Bilashipara, Assam and at the time of unloading the materials, the staffs of the said branch came to know that the rope (*Rassa*) and *tripal* of the said vehicle was cut and some materials had been stolen on the way from the truck.
