I, Anna Biswas, daughter of Subhash Biswas, R/o. Chowpukuria, P.O. Chowpukuria, P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal would like to state as follows:-

1. That at present I am a student of Naxalbari College & my age is 20 years. I have been admitted to Naxalbari College in the month of August, 2023.
2. That in the month of January, 2023 there was a programme at our neighbours house where I met one boy namely Akash Sarkar, S/o. Unknown, C/o. Paritosh Saha, Flower shop at BYMSA Club premises, Bihar More, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014. The boy came there at Chowpukuria to decorate flowers at my neighbours house.

Thereafter Akash Sarkar sent me friendship request in Facebook and requested me to talk with him and he would be my friend. Trusting him we became friends but Akash Sarkar had ill motive and he started taking photograph of myne without my consent. I had no knowledge
