Sir,

In producing herewith one accused person namely Rajesh Karjee (45 years) S/O-Karna Singh Karjee of Samuktala Bazar, PS-Samuktala, Dist-Alipurduar A/P-Limbu Busty, near Parijat Club, Ward no-42, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

1] 20 (Twenty) bottles of OYE OYE 70 UP Country spirit (each bottle containing 300 ml)

I, PSI Chiranjit Saha, s/o-Madhab Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Rajesh Karjee (45 years) to the effect that today on 23/09/23 at about 17.25hrs while performing my evening patrolling duty, received a source information that one person is selling liquor in a hotel situated at Bangla Bazar under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with other officers and force- SI Rantu Haldar, SI Mrinal Basunia, C/1426 Prashanta Kumar Dutta had been to Bangla Bazar under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.1205,dated-23/09/2023. On reaching there and as identified by the source it found that one person was selling and storing liquor in a hotel at Bangla Bazar. Subsequently, I along with officers and force cordoned the hotel and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his hotel. On demand he failed to produce any valid license/papers for selling and storing of such bottles of liquor. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(Six) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 18.15 hrs to 18.55 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Rajesh Karjee (45 years) S/O-Karna Singh Karjee of Samuktala Bazar, PS-Samuktala, Dist-Alipurduar A/P-Limbu Busty, near Parijat Club, Ward no-42, P.S- Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Rajesh Karjee (45 years) S/O-Karna Singh Karjee of Samuktala Bazar, PS-Samuktala, Dist-Alipurduar A/P-Limbu Busty, near Parijat Club, Ward no-42, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
