Sir,

In producing herewith one accused person namely (1) Papon Biswas (25) S/O Sri Sujit Biswas of Thakurnagar Eastern Bypass PS New Jalpaiguri Dist Jalpaiguri in custody arrested and the following articles under seizure: -

- i. 04 (Four) boxes of "SPASMO-PROXYVON PLUS" Dicyclomine Hydrochloride Tramadol, Hydrochloride & Acetaminophen Capsules each box containing 18 strip (Total 4 x 18 strip) =72 strip, each strip containing 8(eight) Capsules), Manufactured by Akums Drugs & Pharmaceuticals Ltd. Marketed by WOKCKHARDT LTD, B. NO- WAA1069 , MFD-06/2021 , EXP 05/2023, per strip worth Rs.61/- total (72 x 61)=4392/-, marked as exhibit "A-1" . One strip of capsule containing eight capsules taken from exhibit "A-1" as sample marked as exhibit "S-1".
- ii. 24 (Twenty-Four) boxes of "Nitrosun-10" Nitrazepam Tablets IP, each box containing 10(ten) strip, each strip containing 10 tablets. (Total 24 x10) =240 strips, manufactured by Sun Pharmaceuticals, IND LTD, B. NO- DFC4139A, MFD -11/ 2021, EXP Date 10/2024, per strip worth Rs.59.50/-, total (240 x 59.50) =Rs.14280/-, marked as exhibit "B-2" One strip of tablets containing 10 (Ten)tablets taken from exhibit "B-2" as sample marked as exhibit "S-2".
- iii. One red & Yellow stipe hand bag in which the above articles was kept. marked as exhibit "C-3"

I, S.I Pradip Kr Singha S/O Late Radhashyam Singha of Ashighar Out Post PS Bhaktinagar SPC do here by lodge this complaint to the effect that on 25.09.2023 at 17 35 hrs received a secret source information that one person is standing at, Tharughati near Shib Mandir, Ashighar and he possess huge quantity of restricted narcotic drug with a view to sale the same in Siliguri area and its adjoining area. Accordingly, I diarised the matter vide ASG OP G.D.E No.700 Dated- 25.09.23 and informed the matter to O/C Ashighar OP and as per his instruction myself along with ASI Munna Ahmed, ASI Prasenjit Barman, ASI Tapan Kr Roy C/970 Bikash Roy and CV/003 Niranjn Roy left for Tharughati near Shib Mandir area in a Govt vehicle along with investigation kit and Video Grapher namely Sourav Kr Das at 17.45 hrs to verify the veracity of the information vide ASG OP GDE No. 701 Dt.25.09.23. On way to Tharughati near Shib Mandir I called two independent witnesses namely (i) Shankar Mandal (41) S/O Late Sunil Mandal of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri and (ii) Gopesh Roy (35) S/O Sri Kaita Roy of Telipara Ashighar Coloney PS Bhaktinagar dist. Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 18.05 hrs on arrival there as identified by the source we cordon the person standing at Tharughati near Shib Mandir with a hand bag in his hand. On being asked he disclosed his identity as noted above. I informed him about the information in hand and he will be searched. After disclosing our identity, I asked him whether he has any objection to be searched in presence of any Executive Magistrate or Gazetted officer and he agreed to be searched in presence of any Gazetted Officer. I served him a notice in accordance with the provisions of law in this regard. Then I send a notice to Shri Passang Topgay Bhutia, ACP, Traffic, SPC cum Spl, Executive Magistrate through special messenger with a request to appear at the spot and remain present as Spl, Executive Magistrate .

After some times at about 19.15 hrs Shri Passang Topgay Bhutia, ACP, Traffic, SPC arrived at the spot. I narrated the whole fact to him and disclosed the identity of Shri Passang Topgay Bhutia, ACP, Traffic, SPC to the accused person as Spl, Executive Magistrate. Under supervision of Shri Passang Topgay Bhutia, ACP, Traffic, SPC the above noted accused person was searched keeping strict regard of his decency and recovered the above packets in presence of Shri Passang Topgay Bhutia, ACP, Traffic, SPC, which he was kept conceal inside a One red & Yellow stipe hand bag. The accused person confessed in presence of Spl, Executive Magistrate and other witnesses that he procured the said restricted narcotic drug clandestinely from Jalpaiguri and other area for the purpose of its selling to the local youths of Siliguri and the adjacent area with a view to earn huge money quickly. On being asked he failed to produce any documents or license in support of his such possession. Then as per direction of Shri Passang Topgay Bhutia, ACP, Traffic, SPC I counted the said packets and found (i) 04 (Four) boxes of "SPASMO-PROXYVON PLUS" Dicyclomine Hydrochloride Tramadol, Hydrochloride & Acetaminophen Capsules each box containing 18 strip (Total 4 x 18 strip) =72 strip, each strip containing 8(eight) Capsules, Manufactured by Akums Drugs & Pharmaceuticals Ltd. Marketed by WOKCKHARDT LTD, B. NO- WAA1069, MFD-06/2021, EXP 05/2023, per strip worth Rs.61/-, total (72 x 61)=4392/- and (ii) 24 (Twenty-Four) boxes of "Nitrosun-10" Nitrazepam Tablets IP, each box containing 10(ten) strip, each strip containing 10 tablets. (Total 24 x 10) =240 strips, manufactured by Sun Pharmaceuticals, IND LTD, B. NO- DFC4139A, MFD -11/ 2021, EXP Date 10/2024, per strip worth Rs.59.50/-, total (240 x 59.50) =Rs.14280/-, recovered in presence of witnesses, and seized all the recovered articles under proper seizure list under the supervision of Shri Passang Topgay Bhutia, ACP, Traffic, SPC, duly signed by the local witnesses and the accused person. The seizure was made in between 19.35 hrs to 20.35 hrs. Then I arrested the above noted accused person after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused person under receipt. Thus the accused person violated the terms and condition of N.D.P.S Act. for possessing the above restricted narcotic drug without any authority. The videography has been done of whole process by videographer.

Under the above circumstances, I pray to you that a specific case under NDPS Act may kindly be started against the accused person namely (1) Papon Biswas (25) S/O Sri Sujit Biswas of Thakurnagar Eastern Bypass PS New Jalpaiguri Dist Jalpaiguri and arrange for its investigation.
