In producing herewith one accused person namely Saroj Rai (M/41 years) S/o- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S- Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12 (Twelve) bottles of SAKI 80 UP Country Spirit (Each Bottle containing 300 ML)
2. 11 (Eleven) bottles of KACHI 70 UP Country Spirit (Each Bottle containing 300 ML)
3. 03 (Three) bottles of KINGFISHER Strong Beer (Each Bottle containing 650 ML)
4. 02 (Two) bottles of TUBORG Strong Beer (Each Bottle containing 650 ML)
5. 02 (Two) bottles of HAYWARDS 5000 Strong Beer (Each Bottle containing 650 ML)
6. 01 (One) bottle of EMBOSS WHISKEY containing 750 ML
7. 01 (One) bottle of Officers Choice Whiskey containing 750 ML

With due respect and humble submission, I PSI Koushik Raha, S/O- Jitendra Raha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above-noted seized articles to the effect that on 25.09.23 at 20.45 hrs while performing PS mobile van duty received source information that one person namely Saroj Rai was selling liquor in his hotel situated at Salugara bazar under Bhaktinagar PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- ¹³⁰⁶ 1256, dated 25.09.23. As per your kind instruction myself along with PSI Chiranjit Saha, ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, C/1426 Prasanta Kr. Dutta proceeded to the PO to work out the information. we reached at the spot, and sometime after, being identified by the source our police party held raid at the hotel of the above-noted accused person and able to detain one person, who disclosed his identity as noted above. On being searched the above-noted bottles of liquor were recovered from his hotel. Further, being asked he confessed that he is doing the business of selling and storing liquor in his hotel since long for his wrongful gain without any valid documents/license. Then, in the presence of available witnesses, I seized the above-noted articles from the PO after prepared proper seizure list. (The seizure was made in between 21.20 hrs to 21.50 hrs). As he has violated the rules and norms of Bengal Excise Act, I arrested the apprehended accused person namely Saroj Rai (M/41 years) S/o- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S- Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Saroj Rai (M/41 years) S/o- Lt Sanu Rai of Salugara Bazar, P.O- Salugara, P.S- Bhaktinagar, Dist-Jalpaiguri under proper section of law and arrange for investigation.
