Sir,

With kind request I, the undersigned would like to draw your attention to the following facts :-

1. That I entered into an "Agreement for Sale with Possession" on 04-05-2021 with (a) Smt. Gandheshwari Roy, wife of Late Mahashankar Roy (b) Sri Kamal Roy (Mobile No. 8436179502), (c) Sri Anrit Roy, both sons of Late Mahashankar Roy and ~~xxxxxx~~ (d) Smt. Supriya Das (Mobile No. 9564109323), wife of Bidesh Das and daughter of Late Mahashankar Roy for sale of land measuring 0.09 Acre, in part of R.S. Plot No. 304, corresponding to L.R. Plot No. 10-44, recorded in R.S Khatian No. 2/24 corresponding to L.R. Khatian No. 946, situated within Mouza Thiknikata, J.L. No. 74, Police Station Matigara, District Darjeeling, and the said land is butted and bounded as North : Land of Sanjay Sarker, South : Land of Benmadhab Sikdar, East : Kutcha Road, West : Land of Plot No. 305, for a valuable consideration of Rs 12,00,000/- (Rupees Twelve Lacs) only and I during the signing of agreement paid the entire sum of consideration money.
2. That the said (a) Smt. Gandheshwari Roy (b) Sri Kamal Roy, (c) Sri Anrit Roy and (d) Smt. Supriya Das did receive the entire consideration money by signing on the said agreement (Xerox copy annexed herewith) and handed me over their original papers relating to the aforesaid land.

(3) That very recently I came to know that the father/husband of aforesaid persons, Late Mahashankar Roy during his life-time did enter into an agreement for sale with Gobinda Chandra Sarkar, Son of Sushil Sarkar, resident of Baghajatin colony, P.S Pradhan Nagar, District Darjeeling for a valuable consideration of Rs 10,00,000/- (Rupees Ten Lacs) only with respect to land measuring 0.09 Acre, in part of R.S Plot No.304 corresponding to L.R.Plot No. 1044 recorded in R.S Khatian No.2/24 corresponding to L.R.Khatian No. 946, situated within Mouza Thiknikata, J.L.No.74 Police station Matigara, District Darjeeling and the said land is butted and bounded as North : Land of Sanjay Sarkar, South : Land of Benimadhab Sikdar, East : Kutcha Road, West : Land of Plot No.305, which is the same plot of land, I did enter into the said agreement. It is pertinent to mention here that the aforesaid persons with whom I entered into the Agreement, did receive consideration money by signing on the money receipts.

4. That however the matter between myself and Gobinda Chandra Sarkar is solved and on mutual consent, we agreed to purchase the land jointly.

That when we approached together to the aforesaid (a) Smt.Gandheshwari Roy (b) Sri Kamal Roy (c) Sri Amrit Roy and (d) Smt.Supriya Das for executing the sale deed in our favour, the aforesaid (a) Smt.Gandheshwari Roy (b) Sri Kamal Roy and (c) Sri Amrit Roy is ready and willing to execute the sale deed but the said Supriya Das refused to execute the sale deed in our favour.

Under the circumstances, I, therefore, request you to kindly look after the matter and take necessary legal steps against the aforesaid persons.
