Sir,

With due respect I am submitting a written complaint against the accused person namely Birman Sahani (23) S/O- Debendar Sahani Vill- SAS Nagar Mahali House No- 520/46 Shiva Enclave ,Pravat Road PS- Jirakpur Dist- Mahali State -Punjab along with the following seized articles as per proper seizure list:

1. Thirty five (35) pcs cartoon each cartoon containing 24 pcs Can Bottles of "Haywards 5000 Premium Strong Beer" each Can Bottle containing 500 ml and having MRP Rs 105/- [Total 840 x Rs 105/- = Rs 88200/-]
2. One white colour Bolero pickup having registration No.BR 06 GE 9406.

I, ASI Pema Dorjee Sherpa of Matigara PS would like to lodge a written complaint against the accused person namely Birman Sahani (23) S/O- Debendar Sahani of SAS Nagar Mahali House No- 520/46 Shiva Enclave ,Pravat Road PS- Jirakpur Dist- Mahali State -Punjab to the effect that today on 29/09/2023 at about 21.40 hrs received a source information that one person was carrying huge quantity of liquor illegally in his four wheeler bearing registration no-ER-06/GE-9406 for transporting from Siliguri and selling the same in the state of Bihar for his wrongful gain. This refers to Matigara PS GDE No- 1658, dated 29/09/2023. I informed the matter to O/C Matigara PS about the information. As per his kind instruction I, along with C/523 Saanjit Kundu, C/1053 Paresh Rana and C/VE/ 977 Ganesha Paswan all of Matigara PS had been to Medical More, Shivmandir under Matigara PS to work out the information. At 22.05 hrs we reached at the spot, and called two independent witnesses namely 1] Kamallesh Gupta (46) S/O Lt. Paras nath Gupta of Khalai Bhaktari PS-Matigara Dist-Darjeeling 2] Md. Firyad S/O Md Anish of Tulsinagar PS Matigara Dist- Darjeeling and shared the information to them. I then called the source to identify the Vehicle of said person and being pointed and identified by the source I along with accompanied team detained one white colour Bolero pickup having registration no. BR 06 GE 9406 and one person who disclose his identity as Birman Sahani (23) S/O- Debendar Sahani Vill- SAS Nagar Mahali House No- 520/46 Shiva Enclave ,Pravat Road PS- Jirakpur Dist- Mahali State -Punjab who was driving the said vehicle.

I then along with accompanied team searched the said vehicle in presence of witnesses and recovered the above noted seized articles from the said vehicle which was loaded at back side of the vehicle. On being asked driver of the said vehicle confessed that he has been engaged in this illegal business since long and used to transport and sell the Liquor illegally in the state of Bihar for his wrongful gain without any valid documents. I seized the above noted articles from the said vehicle and took signature of the witnesses and accused. The seizure was made between 22.35Hrs and 22.55 Hrs as per proper seizure list.

I, therefore request before your kind honour that a specific case may kindly be started against the accused person namely Birman Sahani (23) S/O- Debendar Sahani Vill- SAS Nagar Mahali House No- 520/46 Shiva Enclave ,Pravat Road PS- Jirakpur Dist- Mahali State -Punjab under proper section of law.
