Respected Sir,

with due respect and humble submission I beg to state that I Bishal Sahani, S/O - Suresh Sahani, Permanent residence of Masjid Para, Lower Bajdogra, want to inform you that I am the staff of Mr. shop-16, Licence No:- 132700200016, Mr. shop-Name - Arati Ghosh, that today near about 11.30 am we are doing the distribution of ration under duare ration scheme of Govt. of West Bengal at M.M. Terai, on that time a consumer of our Mr. shop named Bimal Lama, S/O - Not known to me of M.M. Terai came for lifting ration but due to bio-metric authentication, it's take time to generate the bill. But he was in hurry and he says that it's urgent to me, so, I tried to do the bill but his finger was not detected in our machine. So, I told him to go and take rest and send someone from your family to lift the ration. He went away from there and after sometime he came with his son named, Roshan Lama, S/O - Bimal Lama, residence of M.M. Terai came and started abusing me with slangs and filthy languages. I oppose the way he was talking. The people of there who came to lift the ration support me but suddenly Bimal Lama and Roshan Lama started hitting me with punches. On that time our staff and local people rescued me from them. After that Roshan Lama threatened me that if you come again to M.M. Terai then again he will do this.

So, I request you to take necessary action regarding the issue that I can do my job without any fear.
