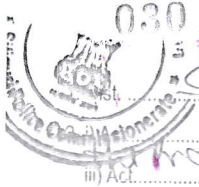

Sir,

In producing herewith one arrested accused person namely Md Rafiqul (22) S/o Md Faruque of Halal Busty PS Bagdogra Dist. Darjeeling (Driver of Vehicle No. WB-73-F-6401) under proper Memo of Arrest along with seized articles and the copy of seizure list viz.

1. One Vehicle (TATA ACE) having Registration No. WB-73-F-6401.
2. Seven (07) numbers of Cows including three (03) calves in different color and different size which carrying in the Vehicle bearing No. WB-73-F-6401.

I, PSI Abhijit Das Of Bagdogra PS under Siliguri Police Commissionerate do here by lodged a written complaint to the effect that on 01.10.23 I alongwith C/900 Rishikesh Barman and CV-923 Pandit Nagasia performed morning mobile duty vide Bagdogra PS GDE No. 07 dt. 01.10.23 and during mobile duty at 10-35 hrs I received a secret source information that one vehicle is being loaded cows illegally going through AH-02 towards Siliguri side from Naxalbari side without any valid documents/papers and if immediate action is taken, it can be apprehend. Accordingly I shared the information to duty officer and OC Bagdogra PS. Thereafter as per his direction myself alongwith force and also C/351 Chandan Debnath, CV-386 Kishore Howladar and CV-375 Jogesh Barman left for verify the veracity of information. At 10-55 hrs we reached at Janglibaba more and started upcoming vehicle checking on the road and on identified by the source we intercepted the above noted TATA ACE vehicle and apprehended the driver of the said vehicle. During search it is found that the vehicle bearing No. WB-73-F-6401 was loaded with Seven (07) numbers of Cows including three (03) calves in different color and different size illegally. On being asked the driver of the said vehicle disclosed his name and address mentioned above and also stated that he was carrying those Cattles in his above noted vehicle from Naxalbari side to Fulbari side, Jalpaiguri for selling the same illegally and also stated that he was carrying the said cattles for his illegal gain. On asked, he failed to produce any valid License/ papers in support of carrying the said Cattles in the said vehicle and also failed to produce any papers in respect of the said Cattles. It is suspected that the recovered Cattles were stolen from anywhere. On further checking it was found that there was no arrangement made for food and water for the said animals as per Govt. rules. Besides this there was no sufficient space for the said animals in that vehicle as per law. The apprehended driver of the above noted vehicle also failed to produce any papers/documents in support of the said vehicle in that time. Accordingly I seized Seven (07) numbers of Cows including three (03) calves in different color and different size and One Vehicle (TATA ACE) having Registration No. WB-73-F-6401 which was use to carry the seized Cattles illegally under proper seizure list and arrested the above noted accused driver U/S 41 Cr P.C, informing him the grounds of arrest as he is violation of The Prevention of Cruelty to Animals Act 1960. All seized Cattles handed over to " Amaidighi Khoyar" at Fulbari for safe custody. The seizure and arrest have been made in between -11-15 hrs to 12.35 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Md Rafiqul (22) S/o Md Faruque of Halal Busty PS Bagdogra Dist. Darjeeling to arranged for its investigation.
