Sir,

With due respect and humble submission, I SI Sandip Datta, O/C Ambari Falakata OP, under NJP PS, SPC beg to lodge this written complaint that today on 28/09/2023 myself along with SI. Swadesh Saha, ASI. Biswajit Ghosh, ASI. Kajal Chakraborty and C/505 Tapash Dutta, C/975 Swarup Basak were performing L/O. duty in c/w Nabi Diwash Rally at Bandhunagar under Ambari-Falakata OP and at about 11:05 hrs received information from the local people of Gandar More that an accident took place at NH-31D near Gandar More Masjid and local people apprehended the offending vehicle at Gandar More. Immediately I informed van officer SI. Kamal Biswas along with C/393 Shyamal Roy and C/798 Paban Sarkar who were detailed to perform Morning Mobile Van Duty w.e.f. 07:55 hrs to 14.00 hrs with Govt. vehicle Vide MCC No.1978/2023 Dated: 28.09.2023. After reaching at Gandar More area at 11:25 hrs van officer SI. Kamal Biswas informed me that approx 1200 to 1500 peoples blocked the NH-31D and the people became violated. Accordingly, myself along with above noted officer and forces rushed to NH-31D at Gandar More and reached there about 11:45 hrs. On the way I informed the matter to Control Room, SPC, O/C NJP PS and other superior officers of SPC. After reaching there we found that a huge traffic jam on this NH 31D highway where ambulance, defense vehicle, VIP vehicles, passenger vehicles and goods vehicles were stuck. On being asked local people of Gandar More stated that two persons namely (1) Hamidar Md. of Birban and (2) Ayub Ali of Sahudangi Hat were dashed by one bus bearing no. WB-63 1833. Over this both of them received grievous injury and shifted to Maharaja Agasen Hospital, Fulbari and now their condition is unstable. Immediately myself along with force intervene the matter and trying to control the mob and also tried to clear the road. On that occasion an Unruly mob more or less 100 persons pelting stone on the vehicles which were stuck in this highway. We tried hard to stop them but the mob attacked us and started scuffling with us. I again informed the matter to O/C NJP PS over telephone and also requested him to provide re-enforcement team immediately. After that at about 12:15 hrs we succeed to running the vehicular flow on the highway and the highway was blocked from 11:15 hrs to 12.05 hrs. In the meantime unruly mob tried to set fire on the offending vehicle and we tried our best but all in vain. At last the mobs under the leadership of (1) Molin Roy of Badlagachh, (2) Vovi Md. Of Harshing Jamadargachh, (3) Md. Ajjjul, S/o. Janab Ali of Shelterbari and (4) Md. Jarin, S/o. Janab Ali of do set fire on the offending vehicle and assaulted us with fist and blows and also pelting stone upon us to discharge our Govt. duty. Over this SI. Kamal Biswas received sustained severe injury over his forehead caused by pelted stone and I along with SI. Swadesh Saha and C/505 Tapash Dutta were also received injury by fist and blows. In the meantime re-enforcement team consisting of SI Partha Sarathi Das, O/C NJP PS, SI. Hirukanti Sarkar, O/C Milanpally OP and I/C, Rajganj PS, Jalpaiguri along with other officers and forces reached at the spot. As the P.O is bordering with NJP PS & Rajganj PS hence I/C Rajganj PS along with forces also trying to intervene the matter. Lastly, finding no other alternatives we all chased over the unruly mob and thus the situation came under control and in the mean time the above noted four accused persons and 100 others succeed to flee away from the spot. After that fire brigade came at the spot and doused the fire. The above noted four accused persons who are directly involved to create this type of incident where common people suffers a lot. After control the situation we all the four police personnel of Ambari -Falakata OP under NJP PS, SPC treated at Rajganj Rural Hospital.

Therefore, I pray before your kind honor that a specific case under proper section of law may kindly be started against (1) Molin Roy of Badlagachh, (2) Vovi Md. Of Harshing Jamadargachh, (3) Md. Ajjjul, S/o. Janab Ali of Shelterbari and (4) Md. Jarin, S/o. Janab Ali of do and 100 others for its investigation.
