Sir,

With due respect, I am producing herewith the 02 (two) arrested accused persons namely 1) Rashid Khan (22), S/o- Firoj Khan of Govt. Saw Mill Road, Mahanahda Para, W/No. 4, PS- Siliguri, Dist- Darjeeling and 2) Bhanu Ray (40), S/o- Lt. Bacchan Ray of Rasouli, PO+PS- Masra, Dist- Chapra (Bihar) and the following articles under seizure :-

1. One Truck (Dumper) bearing registration No.- WB 73 G / 0486 loaded with crushed stone chips.
2. One Truck (Dumper) bearing registration No.- WB 73 G / 0304 loaded with crushed stone chips

I, SI Shib Sankar Das, presently attached with NJP PS under your kind control, beg to state that on 30.09.2023, during my night mobile van duty, when myself along with force namely C/453 Uttam Dey, C/152 Abdul Kayum Mia all of NJP PS, SPC were at Nougaghat More under NJP PS, at about 00.15 hrs on 01.10.2023, found that two loaded dumpers were coming from Porajhar side. Accordingly, I stopped the both vehicles and found the vehicles were loaded by the crushed stone chips. Then I asked to the both drivers as noted above to produce documents in respect of the loaded stone chips but they could not produce any valid documents regarding this. Accordingly, I inform the matter to O/C, NJP PS over telephone and as per his direction, I seized the both loaded vehicles by preparing proper seizure list and arrested the both accused drivers by preparing proper memo of arrest as noted above.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused persons namely 1) Rashid Khan (22), S/o- Firoj Khan of Govt. Saw Mill Road, Mahanahda Para, W/No. 4, PS- Siliguri, Dist- Darjeeling and 2) Bhanu Ray (40), S/o- Lt. Bacchan Ray of Rasouli, PO+PS- Masra, Dist- Chapra (Bihar) and kindly arrange for its investigation.
