Respected Sir,

With due respect, I Sri. Bikash Chhetri, S/o. Ganesh Chhetri, residing at Ujjanu, Shivnagar, Siliguri, P.O. & P.S. Pradhannagar, Dist. Darjeeling beg to state that one Navish Agarwal, resident of Sevoke Road, Siliguri who is known to me since last few years called me on 24.09.2023 and told me that he has to go to Kolkata for selling the shares of his factory as he has some financial crisis. He has requested me to accompany with him to Kolkata for the for his said dealing, and on 24.09.2023 at 7:09 P.M, he has sent me a flight ticket for 25.09.2023 (Flight No. 6E-6175). Again at night, he has told me that for some reason we have to go on 26.09.2023 (Tuesday) and not on 25.09.2023. Though there was chemotherapy of my father on Tuesday, after many request, I was agreed to go with him on 26.09.2023 to Kolkata. Thereafter on 25.09.2023 at 8:28 P.M, he has sent me another flight ticket for journey from Bagdogra to Kolkata on 26.09.2023 (Flight No. 15-319). On 26.09.2023, at about 8:45 A.M., said Navish Agarwal came to the front of Sinclairs Hotel, situated at Mallaguri, Pradhannagar for picking me but surprisingly I found that his mother Pratima Agarwal also going to Kolkata with us, when I have told him that as his mother is accompanying with him whether there is necessity of me to go with him, but he has informed me that his mother is going to the house of his maternal uncle situated at Kolkata and requested me to go with him. On good faith, I went to Kolkata with said Navish Agarwal. We have arrived at Kolkata at 11:40 A.M.(approx). After reaching at Kolkata Airport, Navish Agarwal started to talk with one driver for a considerable time (approx 15-20 minutes) while as per his direction I was sitting away. Thereafter, he has sent his mother through a vehicle. Subsequently he has called a person for sending vehicle for us, he told me that the buyer of his factory has been sending vehicle for picking us. After 5 to 7 minutes, one white coloured Scorpio car came in front of us (the car was at Exit 1A and 1B at the said time) and picked us from the airport area, there was a gunda type person with the Driver. While I was in the car, I found Navish Agarwal was continuously talking with some persons over phone. When I doubt, I sent my location to my wife. After reaching, I found that an almost destructed house is there. I have requested Navish to leave that place because the place is very suspicious. Suddenly I found that his mother is also there. When I asked them about all these things, some 7 to 8 persons come outside and catched me and forcibly brought me inside the said house, there was other 8 to 9 persons inside. They have started to assault me brutally by bamboo stick, shown deadly weapon. Then they took me to another place and after opening my cloths, they have assaulted me by sticks, lathis, battams. Finally they have asked me to call my wife and ask her that someone will go to my house and to give 30 lacs to them, then only they will release me. I have then called my wife but inspite of their direction, I have narrated my wife that I have been kidnapped by Navish Agarwal and his mother and they are trying to kill me. They have taken back my mobile immediately and when my wife frequently tried to call me, the mother of Navish Agarwal received her call and tried to misguide my wife but I have shouted so that my wife could understand. Thereafter, I have asked Navish to do anything to me as I have already told my wife. At about 4:30 P.M, Navish Agarwal and his mother left the said house by saying those goons to kill me. After their leaving, I have tried to convince the said goons that I have my wife and children, my father is a cancer patient and after so many requests and when they found that I sustained grivious bleeding injury in my head and other body parts, they have returned back my mobile and taken me to another place on the same day (26.09.23), after finding my mobile I have shared my location to my family. At night said goons have given me some medications by calling a Doctor in that house. Six stitches were given on my head by said Doctor, they have confined me in the said house till27.09.2023. they frequently talked with Navish over phone. I have requested them to call Navish in that place as I will request him to release me. On 28.09.2023, at 10-10:30 AM, the goons have taken me to another place which is a hotel. I could not see the name of hotel and location. I have called Navish and his brother several times so that I could be released but they did not accept my phone call. On 28.09.2023 at midnight, I have tried my level best to escape and after all efforts, at about 4:45 to 5:00 AM(29.09.2023), I have escaped from that place. I have called a person who have travelling agency at Darjeeling More and said person has sent a flight ticket to my mobile and somehow I could come back to my house on 29.09.2023.

On 29.09.2023, after reaching to my house, my family members have taken care of my me and took me to Hospital. I was in a very horrible situation and yesterday due to my physical and mental illhealth, I could not lodge complaint to you.

Therefore, I request you to investigate the matter and to take necessary legal action against Sri. Navish Agarwal, his mother Pratima Agarwal, resident of C/o. Suresh Agarwal, Bankim Nagar, Ward No. 41, Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri and their men and persons for punishing them. And for this kindness, I shall much oblige to you.
