In producing herewith one accused person namely Suresh Das (55 years) S/O-Lt. Rajbihari Das of Palta Para, Ichapur, P.S-Noapara, Dist-North 24 Parganas A/P-Betgara, near Masjid, P.O.-Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri (Not verified) along with following articles under proper seizure list-

- 1] 14 (Fourteen) bottles of Kingfisher Strong beer (each bottle containing 650 ml)
- 2] 07 (Seven) bottles of Tuborg Strong beer (each bottle containing 650 ml)
- 2] 06 (Six) bottles of Haywards 5000 Strong beer (each bottle containing 650 ml)
- I, PSI Chiranjit Saha s/o-Madhab Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Suresh Das (55 years) to the effect that today on 01/10/2023 at 14.15 hrs while performing my special raid duty, received a source information that one person is selling liquor in his hotel situated at Salugara Bazar under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with officers and force- SI Mrinal Basunia, PSI Koshik Raha, CVF-935 Biplab Roy had been to Salugara under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.31,dated-01/10/2023. On reaching there and as identified by the source it found that one person was selling and storing liquor at his hotel displaying named as "Annapurna Hotel" outside the board of the said hotel. Subsequently, I along with officers and force cordoned the hotel and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 16.05 hrs to 16.55 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Suresh Das (55 years) S/O-Lt. Rajbihari Das of Palta Para, Ichapur, P.S-Noapara, Dist-North 24 Parganas A/P-Betgara, near Masjid, P.O.-Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri (Not verified) after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Suresh Das (55 years) S/O-Lt. Rajbihari Das of Palta Para, Ichapur, P.S-Noapara, Dist-North 24 Parganas A/P-Betgara, near Masjid, P.O.-Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri (Not verified) under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
