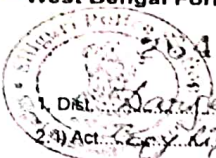

Most respectfully, I Mr. Ashrafuddin Fayazuddin Inamdar S/O Fayazuddin of Sr No. 30/1 /3 Shastrinagar, Near Duttta Mandir , Rahatani , PS- Waked, Dist- Pune, Pune- 411017 appointed to do market survey & detect violation of Copy Right, Trademarks and Patents on behalf of Zed Black Premium Incense Stick of Mysore Deep Perfumery House, Manufacturer & Exporter of Consumer Goods of Servey No. 9 SDA annex, Lasudia Mori, Indore-452010, MP, India and Mongaldeep Brand Incense Sticks of ITC Limited authorized by Brand Protection Services Pvt. Ltd. 9ISO 9001:2008 Certified Company) having office at : 106, 1st Floor , Pocket 2 Jasola, New Delhi-110025 (India) beg to submit that today (30.09.23) during my ,market visiting it came to my notice that one owner namely Amit Talukdar S/O Lt. Amar Talukdar of Shop styled as Sri Sri Ram Thakur Agarbatti Centre manufacturing /wholesaling duplicate/ counterfeited Zed Black Premium Incense Stick of Mysore Deep Perfumery House by using the Trade Mark, Brand Name and Copyright at Shop styled as Sri Sri Ram Thakur Agarbatti Centre at Nevidita Market , Alupatty PS- Siliguri Dist- Darjeeling with view to cheated the innocent people for his wrongful gain.

It is also to inform you that previously same kind of offence had committed by said Amit Talukdar owner of Sri Sri Ram Thakur Agarbatti Centre and a case was lodged against him in Siliguri PS vide case No.154/18 Dt.27/03/2018 u/s 63/65 Copy Right Act.Under this circumstances, the alleged owner of Shop styled as Sri Sri Ram Thakur Agarbatti Center is violating section 63 of Copy Right Act 1957 and 103/104 Trade Mark 1999 and 468/420 IPC.

So, I, therefore request you to take lawful action against the shop owner namely Amit Talukdar S/O Lt. Amar Talukdar Shop styled as Sri Sri Ram Thakur Agarbatti Centre for manufacturing /whole selling duplicate/ counterfeited Zed Black Premium Incense Stick and of Mysore Deep Perfumery House and Mongaldeep Brand Incense Sticks of 'TC Limited by using the Trade Mark, Brand Name and Copyright with proper Section of law.
