Sub-Written complaint

Respected Sir/Madam,

I, SMT. SUJATA CHAKRABARTI, Wife of Sri Sumon Roy Chowdhury, Daughter of Late Sukumar Chakborty, residing at Flat No. 4, Udayan Apartment, Near Children Park, Siliguri Bazar, P.O. & P.S. Siliguri, District - Darjeeling, Pin Code - 734005, do hereby lodging this written complaint with the following effect :-

1. That I got married to one Sri Sumon Roy Chowdhury, son of Late Saroj Roy Chowdhury, resident of Sukanta Pally, Siliguri, P.O. & P.S. - Siliguri, District - Jalpaiguri, Pin -734004, as per the Hindu Rites and Customs on 22.01.2017 at Alipurduar junction Institute Ground, Alipurduar, P.O. & P.S. Alipurduar, Pin Code - 736123.
2. That before of our marriage I was told that my matrimonial house was owned jointly by my husband along with his brother and all marital functions were going to held at the said house. Just prior to our marriage my husband told me that he had some dispute with his brother and he was going to stay in a rented apartment for few days. But after some days of our marriage I came to know that my in-laws has thrown out my husband from my matrimonial house due to his inhuman nature and harsh behavior and that he had no share in that house. From the first day of our marriage I and my husband resided together at rented premises in Siliguri from January 2017 to September, 2017. In the month of October, 2017 me and my husband both shifted together at another rented premises near R. B. S. Club, Children Park, Siliguri, P.O. & P.S. Siliguri, District - Darjeeling, Pin Code - 734005. Then in the month of November, 2019 my husband brought a 2BHK Flat in my name at Flat No. 4, Udayan Apartment, Near Children Park, Siliguri Bazar, P.O. & P.S. Siliguri, District - Darjeeling, Pin Code - 734005. It is pertinent to mention here that my husband is a businessman, dealing in land brokering, also have an agarbati factory and CNF of many food product companies.
3. That after the lapse of 3(three) months of our marriage I got pregnant. During my pregnancy period I used to be forced by my husband to do all the household works and at that time none of my in-laws were there to support me. After few months of my pregnancy I had suffered with some serious physical problems such as menstrual bleeding and immediately I asked my husband to take me to the hospital, but he did not pay any heed to my requests and he only took me to G. B. Das Nursing Home in Siliguri after elapse of 21 days. On such visit the doctor suggested me to abort the child as it is already too late and it could also put my life at risk. Due to such events I had to face severe mental and physical breakdown and even in such scenario my husband never supported me. After elapse of few months of my miscarriage when I asked my husband about having a baby, he totally denied it and told me that he did not want a child because of his work pressure and also did not want to undertake my financial burden.

4. That on December 2017 I went to my parental house for my brother's wedding and stayed there for two months. After returning to my Matrimonial house on March, 2018 I noticed my husband's behavior towards me had totally changed. It is pertinent to mention here that in the 1<sup>st</sup> year of our marriage me and my husband were performing all marital obligations and having good matrimonial life, but after one year of our marriage his behavior completely changed towards me. Everyday my husband used to come late at night in an intoxicated condition and did not speak a single word to me; if I asked anything to him he started beating me and also refused to co-habit together like a normal husband and wife. At first I thought everything would be fine with time but things kept getting worse day by day. My husband always used to feel irritated for no reason. Whenever I tried to communicate with my husband, he always tried to beat and abused me with filthy languages. In spite of all this I asked my husband several times about the reason for his abnormal behavior, but he replied nothing and told me that "I am just overthinking and should go to a mental hospital for treatment" and he always tried to avoid these conversations with me. In the month of November, 2018 my husband told me that he need to go to Kolkata for his urgent business work and once he left for Kolkata he disappeared for many days and during that period he blocked my phone number and did not even contact me.
5. That ever since his return from Kolkata my husband always come home at around 4' O clock in the morning and use to leave home early in the morning and didn't contact me for the whole day. Thereafter on 30<sup>th</sup> November, 2018 out of curiosity I checked my husband's phone and saw some pictures of him with a girl named Mampi Das and also witnessed vulgar Whatsaap chats with her, shocked by such revelations I asked him about the same he beat me up and told me to keep mum otherwise he will kill me. When I told my in-laws about his illicit relationship, my in-laws told me that my husband cannot do such kind of thing and that I have some mental problem.
6. Having no other choice left in the month of February, 2019, I complained to The Councilor of Ward No. 25 of Siliguri Municipal Corporation, Siliguri, Dist. Darjeeling about my husband's illicit relation and that almost every day he beat me up in an intoxicated condition. In the month of October, 2019, my husband told me that he is not going to return home for sometime and left me alone and I was suspecting that something was wrong. I followed him and my suspicions was confirmed when I discovered that my husband had rented an apartment in Haidarpara and was living with Mampi Das with whom he is in an illicit relationship. Thereafter when I inquired to the other people of the area I came to know that they are living there as husband and wife. After knowing that when I called my husband to return to the house that women Mampi Das picked the call and threaten me not to call again my husband and also told me that if I again tried to contact with my husband she's going to kill me.
7. That in order to save our marriage I forgave my husband for all his deeds and decided to start our relation fresh, thought that if I conceived my husband to have a baby then the relationship between me and my husband would become better. So I told my husband about this but he did not show any interest. Somehow I managed to convince him for a test-tube baby and after so many requests he agreed to take me to Chennai. On February, 2020,

me and my husband along with my mother went to Chennai to get in touch with a trusty Test-tube baby clinic for a test-tube baby. After initiating the procedure for a test-tube baby suddenly my husband's mind changed and he told us that he did not have sufficient money for the whole process and we have to go back to Siliguri. In spite of all my requests the next day we came back to Siliguri and on our return again he started to torture me physically and mentally.

8. In the month of December, 2020, after returning from Chennai I again tried to convince my husband to have a baby. Somehow he agreed and in Siliguri I conceived with a test-tube baby but due to some medical inconvenience I had a miscarriage. In the month of March, 2021, my husband told me that he cannot stay with me and wants to leave our house. When I tried to stop him he brutally beat me and threatened me not to interfere in his life. But Somehow with much request I managed to convince him to stay. I also lodged a written complaint against Mampi Das to Siliguri Police Commissionerate in the month of March, 2022 about that woman who continuously disturbing my husband and interfering into my marital relation. In the month of October, 2022 for the third time I got pregnant with a test-tube baby in Siliguri at. After 4 months of my pregnancy one day I came to Haidarpara and caught my husband red handed with that woman namely Mampi Das. When I tried to convince my husband to stay with me and leave that woman suddenly the atmosphere got heat up and that woman namely Mampi Das along with my husband started brutally beat me up and continuously kicked on my stomach as a result again I got miscarriage. After facing so much mental and physical torture I am feeling suicidal now. In the month of December, 2022 my husband left me alone and started staying with that woman in Haidarpara, when he left the house, he did not give me a single penny. Whenever I tried to called my husband for settle the dispute between us and tried to meet with my husband at Haidarpara where he is staying with that woman that woman named, Mampi Das; she started crying and did not allow me to communicate with my husband and she also beat me and threatened my husband not to contact with me also threaten if my husband tried to communicate with me then she will commit suicide. In this situation as a house wife it is tough for me to bare my minimum regular expense. Even he did not paying our flat's E.M.I. for three months. Initially my parents were supporting me financially, but presently they are undergoing treatment and is impossible for them to bear my expenses.

I am, therefore, requesting to kindly take immediate and necessary action against above-named persons.
