In producing herewith 02 (two) arrested accused persons namely (i) Rajib Paswan (32 yrs) S/O Sukdeb Paswan of C/O Chandeswar Paswan of Rajendra Nagar, Collipara, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Promod Paswan (38 yrs) S/O Late Gita Paswan of Tikiapara, Majdur Colony, Ward No 28, PS- Siliguri, Dist.- Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with them.

- (i) 31 (thirty one) bottles of **KINGFISHER IMPERIAL STRONG BEER** containing 650 ml in each bottle (i.e. total - **20.150 Itrs**) and marked as Exhibit "A" and out of which 01 bottle Bottle of the same taken as sample for examination and marked as Exhibit "A1".
- (ii) 19 (nineteen) bottles of **HAYWARDS 5000 PREMIUM STRONG BEER** containing 650 ml in each bottle (i.e. total - **12.350 Itrs**) and marked as Exhibit "B" and out of which 01 bottle Bottle of the same taken as sample for examination and marked as Exhibit "B1".
- (iii) 12 (twelve) bottles of **TUBORG PREMIUM BEER** containing 650 ml in each bottle (i.e. total - **7.800 Itrs**) and marked as Exhibit "C" and out of which 01 bottle Bottle of the same taken as sample for examination and marked as Exhibit "C1".
- (iv) 05 (five) bottles of **BUDWEISER MAGNUM PREMIUM INTERNATIONAL BEER** containing 650 ml in each bottle (i.e. total - **3.250 Itrs**) and marked as Exhibit "D" and out of which 01 bottle Bottle of the same taken as sample for examination and marked as Exhibit "D1".
- (v) 03 (three) bottles of **BUDWEISER PREMIUM KING OF BEER** containing 650 ml in each bottle (i.e. total - **1.950 Itrs**) and marked as Exhibit "E" and out of which 01 bottle Bottle of the same taken as sample for examination and marked as Exhibit "E1".

I, SI Goutam Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused persons namely (i) Rajib Paswan (32 yrs) S/O Sukdeb Paswan of C/O Chandeswar Paswan of Rajendra Nagar, Collipara, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Promod Paswan (38 yrs) S/O Late Gita Paswan of Tikiapara, Majdur Colony, Ward No 28, PS- Siliguri, Dist.- Darjeeling to the effect that today on 02.10.23 at 22.25 hrs I received a specific source information that the above noted two persons stored huge quantity of illicit liquor in the rented house at Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 108 dated 02.10.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with SI Youel Lepcha, CV/992 Jagadish Biswas, CV/645 Pankaj gupta, CV/223 Swapan Chhetri, CV/646 Baban Das and CV/242 Rakesh Monger all of Pradhan Nagar PS left for Rajendra Nagar Collipara to verify the veracity of the information in hand. After arrival at Coolipara and being identified by the source, I held raid at the rented house of the above noted two accused persons and managed to apprehended them. On being asked they disclosed their identity as noted above and on search the above noted liquor was recovered from their possession which they kept in their rented house. On demand they failed to produce any valid license/papers for selling and storing of such articles at their residence. On further interrogation they stated that they are involved in selling and possessing of liquor without any valid license since long for their illegal gain.


Accordingly, I seized and labelled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned two accused persons namely (i) Rajib Paswan (32 yrs) S/O Sukdeb Paswan of C/O Chandeswar Paswan of Rajendra Nagar, Collipara, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Promod Paswan (38 yrs) S/O Late Gita Paswan of Tikiapara, Majdur Colony, Ward No 28, PS- Siliguri, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 22.45 to 23.35 hrs.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against both the arrested accused namely (i) Rajib Paswan (32 yrs) S/O Sukdeb Paswan of C/O Chandeswar Paswan of Rajendra Nagar, Collipara, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Promod Paswan (38 yrs) S/O Late Gita Paswan of Tikiapara, Majdur Colony, Ward No 28, PS- Siliguri, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
