Sir,

In producing herewith one arrested accused person named Niranjan @ Babu Saha (46 yrs) S/O Narayan Ch. Saha of Pabitr Nagar, Lane No. 02, Opp. Mother Teresa School, PS- Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

11(Eleven) bottle of 60 UP HIMALAYAN GOLD Country Spirit, each bottle contain 600 ml, each bottle MRP 155/- (Total 6.6 liters) marked as exhibit A out of which 01(one) bottle has been taken as sample for examination marked as exhibit A1.

I, ASI Manoj Kr. Roy of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the arrested accused person namely Niranjan @ Babu Saha (46 yrs) S/O Narayan Ch. Saha of Pabitr Nagar, Lane No. 02, Opp. Mother Teresa School, PS- Pradhannagar, Dist. Darjeeling to the effect that on 03.10.23 at 12.05 hrs I received a secret source information that one Babu Saha of Promod Nagar under PS- Pradhan Nagar, Dist.- Darjeeling is selling illegal liquor at his residence. Accordingly, I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagar PS GDE No 139 dated 03.10.23 and as per his kind order and direction myself along with CV/128 Ajay Kr. Sahani, CV/223 Swapan Chettri All of Pradhan Nagar PS had been to Pabitra Nagar under PS - Pradhan Nagar to verify the veracity of source information. After arrival at Pabitra Nagar and as identified by the source I held raid at the residence of Babu Saha and managed to apprehended him. On being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were recovered which he kept concealed with a cartoon in his house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Niranjan @ Babu Saha (46 yrs) S/O Narayan Ch. Saha of Pabitr Nagar, Lane No. 02, Opp. Mother Teresa School, PS- Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 12.35 hrs to 13.15 hrs at the spot and arrested him after informing the ground of arrest

I, therefore pray before your good self that a specific case may kindly be initiated against Niranjan @ Babu Saha (46 yrs) S/O Narayan Ch. Saha of Pabitr Nagar, Lane No. 02, Opp. Mother Teresa School, PS- Pradhannagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
