

Sir,
With due respect it is to inform you that on 01/10/2023 at about 5.10 pm. in the evening, an overspeeding motor bike with triple rider, without a helmet, hit my wife Mrs. Bhramalata Sharma at Malismani, Champasari, Milan More Road, Siliguri and seriously injured her left leg with ankle dislocation & fracture, so, in a hurry I immediately take her to nearest hospital "Neotia General Hospital" Siliguri for immediate treatment, and at the time of incident I was also present with her at the scene. However, because I had to rush my injured wife to hospital, I could not pursue the matter then. Now, she was admitted to Neotia General Hospital, Siliguri on the 1st Oct. 2023 in the evening time and had to undergo surgery on 2nd. of Oct. 2023 because of the serious injury sustained due to the accident. Because of the traumatic experience I could not take note of the Bike Registration Number.
