I, Sri. Briendra Pradhan (71) S/o Lt. Lal Bdr. Pradhan of Panchanai Dagapur PS Pradhan Nagar and member and Caretaker of Laxmi Narayan Mandir situated in our village Panchanai Dagapur PS Pradhan Nagar do hereby lodge this information that on 03-Oct-2023 early morning around 03:30 HRS I got information that there is suspicious movement in our above noted mandir. On getting this information, myself with my sons and other villagers rushed to the Mandir and found that the window grill of the mandir has already been broken by the criminals for committing theft inside the Mandir. We thoroughly searched the criminals in and around the vicinity of Mandir and in our village and could find one person named Anish Thapa Mangar (26) S/o Binod Mangar of Lopchu Tea Garden Pulbazar Darjeeling, at present, staying in Aarav Paying Guest here in our village as paying guest since 15 days. On being asked, he disclosed his name and address as noted above. He also admitted that he along with one Bihari Boy of our village have committed criminal trespass in the Mandir and broke opened the grill of the window with a view to commit theft of cash and other valuables of the Mandir but he was caught by the villagers and handed over to the Police Patrol team of your PS along with his driving licence and two smart phones.

It is pertinent to mention here that on the intervening night of 22/23-August-2023 one hanging Brass Bell of Mandir weighing around 5kg was also stolen. Similarly, on 29-Sept-2023 evening around 18:30HRS the donation box kept in the Mandir was broke opened and Rs. 2000/- was stolen. I strongly suspect the role of above noted person(s) in these crimes as well

Under the above circumstances, I, request that necessary legal steps may kindly be initiated against the above person(s),
