- 2. 03 (three) bottles of ROYAL BLUE PREMIUM WHISKY ,each bottle containing 375 ml, each bottle MRP- 150/-(Total 1.12 liters) marked as exhibit B out of which Ol(one) bottle has been taken as sample for examination marked as exhibit B1

I, ASI Jagannath Roy of Pradhan Police Station, SPC would like to lodge this written complaint against two accused person named 1) Sanjay Kumar Thakur 35Yrs/M S/O Bijay Kumar Thakur 2) Lalit Thakur(38Y/M), S/O Lt. Kedar Thakur both of Dubiyahi, Turki, PS- Kudhni, Dist. Muzaffarpur, Bihar to the effect that today on 03.10.2023 at 14.35 hrs received a source information that two person has been waiting with illegal liquor at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagår PS GDE No 155, dated 03.10.23 and as per his kind direction mylself along with CV/128 Ajay Kr. Sahani, CV/223 Swapan Chettri (All of Pradhannagar Ps) had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that above noted persons has been waiting with huge illegal liquor from their possession. Subsequently, I along with my force able to detain the above noted persons. On being asked the apprehended persons disclosed their name and identity as noted above. Further being searched the above noted seized articles were recovered from their possession which were kept with a cartoon. On demand they both failed to produce any valid license/papers for selling and storing of such articles. On further interrogation they stated that they are involved in selling and possessing of liquor without any valid license since long for their illegal gain. Accordingly, I seized and labelled the above mentioned illegal illic t distilled liquor under proper seizure list in presence of witnesses and arrested the above mentioned persons named 1) Sanjay Kumar Thakur 35Yrs/M S/O Bijay Kumar Thakur 2) Lalit Thakur(38Y/M), S/O Lt. Kedar Thakur both of Dubiyahi, Turki, PS- Kudhni, Dist. Muzaffarpur, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.10 hrs to 15.40 hrs at the spot and arrested them after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against 1) Sanjay Kumar Thakur 35Y1 s/M S/O Bijay Kumar Thakur 2) Lalit Thakur(38Y/M), S/O Lt. Kedar Thakur both of Dubiyahi, Turki, PS- Kudhni, Dist. Muzaffarpur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
