Sir,

In producing herewith one arrested accused person named Biplab Ghosh (38 yrs) S/O Kajal Ghosh of Vill- Chapatali, PO- Banchukamari, PS+Dist- Alipurduar under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

I, ASI Bhuban Sharma S/O Late Arjun Kumar Sharma presently attached with Control Room, SPC would like to lodged this written complaint against the above noted arrested accused person named Biplab Ghosh (38 yrs) S/O Kajal Ghosh of Vill- Chapatali, PO- Banchukamari, PS+Dist- Alipurduar to the effect that on 03.10.23 night I was performing night RT Mobile van duty (CS-III) vide MCC No 2333/23 dated 03.10.23. During my duty, I had received an information from the on duty officer of Pradhan Nagar PS that a problem is going on at Hotel Conclave opposite Gurung Busty More under PS- Pradhan Nagar, Dist.- Darjeeling and directed me to look into the matter. After receiving the said information myself along with CV/831 Karamjit Singh rushed to Hotel Conclave by Govt vehicle driven by CD/1705 Ranajit Bitter. After arrival at the said hotel, I noticed one of the customer of the said hotel creating nuisance at the basement area of the said hotel and used slag language to everybody present there. I also found that one sharp cutting weapon (big size scissors measuring approx 18' in length) in his right hand. Then, I tried to control him and asked him for his good behavior but while I tried to talked with him then he became very ferocious and started to assault us by a sharp cutting weapon with the intention to kill us. Causing CD/1705 Ranajit Bitter sustained grievous injury and immediately I send him to Siliguri District Hospital for his treatment. However, we managed to apprehended him and subsequently arrested him U/S 41 Cr.P.C. and seized the said weapon of offence from his possession under proper seizure list in presence of independent witnesses namely (i) Soumitra Barman S/O Ganesh Barman of Satahar, PS- Tapan, Dist.- Dakshin Dinajpur and (ii) Aarush Majumdar S/O Late Gobinda Majumdar of Ramkrishna Pally, Lamding, PS- Lamding, Dist.- Hojai, Assam brought the said arrested accused to Pradhan Nagar PS. The said arrested accused namely Biplab Ghosh (38 yrs) S/O Kajal Ghosh of Vill- Chapatali, PO- Banchukamari, PS+Dist- Alipurduar physically assaulted CD/1705 Ranajit Bitter and tried to assault us and the staff of the said hotel. The said arrested accused namely Biplab Ghosh (38 yrs) S/O Kajal Ghosh of Vill- Chapatali, PO- Banchukamari, PS+Dist- Alipurduar obstructed the police personnel in discharging their lawful duty and assaulted police personnel badly. I also informed the wife of the arrested accused regarding his arrest.

Under the above noted fact and circumstance, I therefore pray before you that a specific case under proper section of law may kindly be started against the above noted arrested accused named Biplab Ghosh (38 yrs) S/O Kajal Ghosh of Vill- Chapatali, PO- Banchukamari, PS+Dist- Alipurduar and arrange for its investigation.
