I also informed the fact to evening RT Van officer SI Shyamal Dutta Roy and force of NJP PS, SPC and directed him to come to Porajhar Ghat to accompany with us. At about 21.05 hrs on 01.10.2023 we arrived at Nouka Ghat More under NJP PS. After a while SI Shyamal Dutta Roy along with force came to Noukaghat More and accompany with us. Then we together left Noukaghat More towards Porajhar Ghat for execute the information.
