With due respect, I am producing herewith the arrested accused persons namely (i) Apan Barman (29), S/o- Lt. Rajen Barman of Thangvanga More, Barivasha, PS- NJP, Dist- Jalpaiguri. (ii) Prabir Sarkar (27), S/o- Lt. Kalipada Sarkar of Banshbari, Bhabesh More, PS- NJP, Dist- Jalpaiguri. (iii) Bikash Roy (36), S/o- Lt. Jagat Ch. Roy of Banshbari, Barivasha, PS-NJP, Dist.- Jalpaiguri, (iv) Swapan Roy (20), S/o- Lt. Pohatu Roy of Thangvanga More, Barivasha, PS- NJP, Dist.- Jalpaiguri. (v) Babu Roy (30), S/o- Lt. Hiramba Roy of Madani Bazar, Barivasha, PS- NJP, Dist.- Jalpaiguri and (vi) Milan Roy (27), S/o- Lt. Bahadur Roy of Krishna Nagar VIP Road, PS- NJP, Dist- Jalpaiguri and the following articles under seizure :-

1. One iron rod measuring 30 cm in length, one screw driver, one wrench from the possession of accused named Apan Barman.
2. One bhojali, one torch light and one small iron rod from the possession of accused named Swapan Roy.

I, SI Shib Sankar Das of New Jalpaiguri PS, Siliguri Police Commissionerate beg to state that on 01.10.2023 at 20.45 hrs. I received a secret source information that a gang of miscreants assembled at Porajhar Ghat, under Mahananda Bridge, PS- NJP, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Shaktigarh area. Accordingly, I informed the fact to you and diarized the matter vide NJP PS GDE No- 40, Dated- 01.10.2023. As per kind order myself along with VP/13 Jamirul Islam, C/453 Uttam Dey, C/1044 Hari Kherwar all are of New Jalpaiguri PS. Siliguri Police Commissionerate left for Porajhar Ghat, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to evening RT Van officer SI Shyamal Dutta Roy and force of NJP PS. SPC and directed him to come to Porajhar Ghat to accompany with us. At about 21.05 hrs on 01.10.2023 we arrived at Nouka Ghat More under NJP PS. After a while SI Shyamal Dutta Roy along with force came to Noukaghat More and accompany with us. Then we together left Noukaghat More towards Porajhar Ghat for execute the information. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled in a dark place at Porajhar Ghat under the Mahananda Bridge, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 06 (six) persons of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Shaktigarh area. They also stated that others 04/06 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 06 (six) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 21.35 hrs to 22.25 hrs on 01.10.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Apan Barman (29), S/o- Lt. Rajen Barman of Thangvanga More, Barivasha, PS- NJP, Dist- Jalpaiguri, (ii) Prabir Sarkar (27), S/o- Lt. Kalipada Sarkar of Banshbari, Bhabesh More, PS- NJP, Dist- Jalpaiguri, (iii) Bikash Roy
