Sir,

I, SI Youel lepcha (28) S/O Jai Tshering lepcha of Pradhan nagar Police station lodged a written complaint against Sukla @ Bura Ghosh (41 yrs) S/O Kartick Ghosh of Ganesh Ghosh Colony ward no 46 PS Pradhan nagar Dist Darjeeling to the effect that today on 04/10/2023 at about 20:10 hrs I received a source information that the above noted Sukla @ Bura Ghosh has stored huge quantity of illicit liquor at his shop cum house for selling his design customer. Accordingly i informed the matter to you and as per your direction I along with ASI Manoj Kr Roy, ASI Biplab Das, CV 242 Rakesh Mangar, CV 992 Jagadish Biswas had been to the spot to verify the veracity of the information. After reach seeing the police team above noted Sukla @ Bura Ghosh flee from his shop cum house. In presence of locals I recovered 15 (fifteen) bottles of Saki 80 up each containing 300 ml blended and bottled by Prakash Distillery & Chemical CO. (P) Ltd Bandrijote Siliguri and 16 (sixteen) Bottles of Himalayan Gold 60 up each containing 600 ml blended and bottled by Himalayan Endeavour Pvt Ltd Siliguri West Bengal. (Total 14.1 liters). Accordingly I seized the same under proper seizure and the whole seizure was made between 20.45hrs to 21.25hrs

As per local inquiry it came to light that above noted Sukla @ Bura Ghosh (41 yrs) S/O Kartick Ghosh of Ganesh Ghosh Colony ward no 46 PS Pradhan nagar Dist Darjeeling is running his business since long.

I therefore request you a specific case may kindly be started against the above noted Sukla @ Bura Ghosh (41 yrs) S/O Kartick Ghosh of Ganesh Ghosh Colony ward no 46 PS Pradhan nagar Dist Darjeeling under proper sections of law.
