Sir/Madam,

With due respect I, the above name complainant wants to state you that :-

1. That in the year 1/12/2021 my son Milinda Lahiri got married with the accused No: 1 who is the resident of Asansol and after the married the accused No: 1 used to reside at Siliguri. After few month of marriage the accused No: 1 made a hot altercation situation and forcefully left the house of my and started residing at Asansol.
2. That at present situation my son Milinda Lahiri is presenty at Kolkata as he is doing a job in a private company.
3. That nearly one years has been passed my son and the accused No: 1 is living separately.
4. That on 24/9/2023 at about 8:00 AM in the morning as I was doing morning walk in the YMA Club suddenly I saw all the accused together with some antisocial men came towards me and surrounded me.
5. That when I asked about the happenings, all the accused started a hot altercation towards me and surrounded me by circle. Suddenly the accused No: 1 to 4 started using slang languages about my death father and other family members. Thereafter all the accused got heated up and declared that as my son have ruined the life of accused No: 1 so they have come to treat me a lesson.
6. That by saying this the accused No: 4 and other unknown miscreants men started snatching my share. The accused No: 4 started and tried to tore my blouse and tried to open my share infront of general public in the road area. When the nearby people came all this accused also threaten that that its there personal matter and not to interfere with it.

7. That in the mean time the accused No: 1, 2 and 3 brought some half brick and tried to hit over my chest and back of my neck. And the accused No: 4 constantly trying to undress me before the public and outrage my modesty.
8. That when I requested then by folded hands to leave me as they took my mobile so I could not able to call my husband, they also snatched my golden chain which I was wearing. Accused No: 1, 2 and 3 action and mentality was to make physical assault to me and to frightened me. They declared that they will be coming from time to time to Siliguri and will harass me and my family members like this manner.
9. That my age is 56 years and having a many problems over my body therefore through this shock and frightenedness I got senseless in the road.
10. That when my sense came I found myself in my bed and the neighbour people was saying that the accused No: 4 tried very badly to open my share and with all protest of the surrounding people he failed in his objective.
11. That thereafter on every 1 hour the accused called in my ph number with different ph numbers and threatened me that if I go to police then next time they will even do more rough harassment then of this time and even can take away life of our family members.
12. That seen this situation I gone into depression and ever time I remember their threat which I cannot tolerate or take it any more.
13. That seeing this situation of the threat of the accused i have no other option rather then seeking the help of local police.
14. That under the above circumstances I request you to start an investigation and also start a specific case to arrest the accused person mentioned above for threatning me, hitting me, outrage my molesty infront of general public and life threat over my family members.
