Respected Sir,

I, Smt. Puja Thapa (Halder), wife of Mr. Tanmoy Halder, and a resident of Haren Mukherjee Road, Hakimpara, Ward No. 12 of S.M.C., P.O- Siliguri, P.S.- Siliguri, Dist- Darjeeling, hereby want to lodge a complaint regarding a distressing incident that took place on 23/09/2023 around 5:00 P.M. at the above-mentioned address.

The incident involved the following individuals:

1) Shyama Prasad Ghosh (Raj), S/o Lt. Bidyut Ghosh, 2) Soma Ghosh, Wife of Shyama Prasad Ghosh, 3) Bidyut Raj Ghosh, Son of Shyama Prasad Ghosh all are resident of - Hakimpara, Haren mukherjee Road, Ward no-12 (S.M.C), P.O & P.S- Siliguri, Dist- Darjeeling,

I have been in the process of constructing a shed at the rear end of our building for godown purposes. For several days, the aforementioned individuals have been obstructing our construction work. On the aforementioned date and time, they forcibly closed the entrance shutter of our tin shed where laborers were actively working and proceeded to threaten them.

Upon hearing the commotion, my husband, brother-in-law, and I rushed to the scene to intervene. Shyama Prasad Ghosh initiated an assault on my brother-in-law using his fists, blows, and an iron rod. When my husband and I attempted to intervene, Shyama Prasad Ghosh, along with his wife and son, also assaulted us. Additionally, they behaved inappropriately by touching me. As a result, my husband and I sustained injuries. Moreover, during this altercation, the mentioned individuals forcibly took an amount of Rs. 10,000 from my brother-in-law's pocket.

Subsequently, my brother-in-law, Mr. Prasenjit Halder, sustained severe injuries and was promptly admitted to Siliguri Hospital for medical attention.

In light of the aforementioned incident, I earnestly request you to take immediate and necessary action against the involved individuals. Your prompt attention to this matter is greatly appreciated.
