late Indradeo Prasad Rajak, Resident of Sir, I, KAJAL RAJJAK, D/O Ganganagar, P.O. Siliguri, P.S. - Khalpara T.O.P. under Siliguri Police Station, Dist Darjeeling, do hereby want to inform you as follows :-

- 1. That on 04.10.2023 at about 9.30 P.M. when my brother namely Bishnu Narayan brought food for me and my mother namely Usha Rajjak at the house situated at the aforesaid address, then I after hearing the noise of a R.S. 200 Bike went outside the house.
- 2. That after that I saw some anti social persons namely 1. KUNDAN DAS, S/O Badri Das, 2. ANKIT DAS, 3. KUNAL DAS, both are sons Kundan das, 4. RINA DAS, D/O Kundan das, 5. FULMATI DAS, W/O Badri Das, 6. GHANSHYAM DAS, S/O Badri Das, and other two brothers of Kundan das all are resident of Ganganagar, Star point School, P.S. Khalpara T.O.P., Dist Darjeeling, started to misbehave with my brother and when I protested against these illegal activities then the aforesaid accused started to use abusive languages on me and my family members.
- 3. That subsequently the aforesaid accused persons started to beat my brother mercilessly and when my brother tried to make them understand then the aforesaid accused became more violent, my brother only to escape, entered into our house

- 4. That subsequently the aforesaid accused persons forcefully entered into our house with the iron rod and started to beat me and my brother with iron rod and hit us on our head and when my mother came to rescues us then the above named accused persons also beat her mercilessly.
- 5. That the above named accused persons tore my clothes and outrage my modesty and when I tried to escape from their hands KUndan Das hit me with iron rod on my head and immediately I started to bleed.
- 6. That the above named accused perons hold my brother and hit him with iron rod on his head and my brother got senseless.
- 7. That after that the above named accused persons ransacked our house and looted each and every household articles by breaking the almirah and trued to set fire on our house.
- 8. That subsequently after the hue and cry of my mother the above named accused persons fled away and threatened to us that if we fail to vacate the house and leave the locality then the above named accused persons will burn us alive.
- 9. That subsequently when I protested against these illegal activities then the accused started to threatened me and my family members that they will kill my family members and threatened to leave the place.
- 10. That subsequently I and my family members were severely injured and was taken to the Siliguri District Hospital and the necessary medical treatment was done.
- 11. That subsequently after returning from the hospital the above named persons again threatened me that if me and my family that if I and my family members did not vacate the house then they will kill me and my family and setting the house of fire and will burn all my family members alive.

That said accused persons, along with some other antisocial persons threatened us that they will set our house on fire and will also implicate the false cases if we try to take any kind of the me in false cases if we try to take any kind of legal action against them then they will kill me and my family members and also destroy our social prestige by implicating me in false cases and no one can obstruct them from doing gO.

That the said accused persons, along with some other antisocial persons are very much furious in their activities and they can do anything with us. After that incident I am feeling very much unsafe for me and my family and our lives, property and honour are in danger.

I therefore request before your good self to kindly look into the matter and take necessary action against the aforesaid accused persons as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
