Sub: Man-handling, hot-exchange and
attempts to murder - CITY MARBLE

This is to inform as under:

- a) Today at about 11.00 AM in front of our gate no. 2, a crowd of about 30-35 people were attempting to dismantle our "CITY MARBLE" board. One gentleman reported to be Shiraj Ghosh and Nixon were leading the mob and the said operation. Instantly all the staff of CITY MARBLE rushed to the gate no. 2.
- b) There were hot exchange. Shiraj Ghosh, Nixon Roy, Raja Deb have started physical manhandling to our staff with abusing language. - Sanjit, Rahul, Bichibis and others (staff) have been abused. Security guard of city marble Sri Ponkaj Goswami has also reached the spot to enquire about the incidents. Shiraj Ghosh and his goons started abusing and manhandling the security guard. They also started physical assault. At one time Shiraj Ghosh took a stone to hit him. One Raja Deb was so furious to murder the security staff at any time, at any place to take revenge. Nearly 30 people have manhandled the security guard and our staff members. Any how we managed to snatch the security guard from the hands of Shiraj Ghosh.

We are very much horrified in the incidents and fearing physical assault including life-threat. Any untoward incident to our CITY MARBLE may also happen at any time.
