Respected Sir,

I Jyoti Das daughter of Jhantu Das aged about 21 years, Hindu by religion, resident of Baghajatin Colony, 45/7, P.O. & P.S.- PradhanNagar District-Darjeeling and presently working in Delhi bas Personal Assistant in Arteform Designs Private Limited would like to report you —

- 1. That on the month of June'2023 asked my elder sister namely Rinki Bibi for a job as she was working in event Management Company (as told by her to our family) and she may arrange a job at her company.
- 2. That since then she started insisting me to hangout with few person unknown to me in Hangover, 87 club, Beer republic etc. all are running their bar cum restaurant club in City Centre, Siliguri. As I need a job so I thought those unknown people may take interview in those venue as it may be related to event management company.
- 3. That since after then she went on meeting me with several people in different clubs and bar but I never got a job and this all instances put me on doubt and I asked her she is arranging interview with so many people/recruiter but no fruitful result is being out. On this reply she replied getting a job is not easy for that you have to sleep with them.
- 4. That I after listening to her I asked whether she is doing the same, she affirmly replied and since then relation with her and my family started to bitter. My mother objected her way of living and my elder sister is also a mother of 10 year old daughter.
- 5. That the situation in my home was so spoiled due to her obscene lifestyle that I decided to look out for job outside Siliguri and luckily in the month of July I got a job in Delhi as Personal Assistant in Arteform Design Private Limited and presently working over there.
- 6. That as soon as I shifted to Delhi several obscene phone calls came to me and all those phone calls were skillfully planned by my elder sister and she tried to make me like her. One Bablu Singh called me and said that my elder sister has taken money by showing me from him to do prostitution. I informed the same to my mother, hearing this my mother asked her to leave our home in Pradhan Nagar, Siliguri. But she physically assaulted my mother before leaving the house. Presently she is residing as a tenant near St.Mary's School, Pradhan Nagar, Siliguri and her contact number is 9903083562.
- 7. That I and my mother did not tried to do any police complain as she was our family member.
- 8. That recently my mother was suffering from medical illness and owing to it my mother asked me to visit Siliguri. So I came to Siliguri just One week has passed and today i.e. on

06.10.2023 today morning my mother called her grand daughter and on that time she (Rinki) was also present with her. And over the phone she started using filthy and abusing language to my mother and me.

- 9. That after putting off the phone she immediately within a 15 minutes came to my house as he heard that I have returned Siliguri and she insisted me to again meet with unknown people.
- 10. That my mother obstructed her and all of a sudden she assaulted my mother and strangulated her and forcing my mother to let me meet with the person whom she has arranged for me and this entire incident was witnessed by the other neighbor as well.
- 11. That before leaving she has warned me that she will kidnap me and traffic me to Bangladesh where no one can trace about me.
- 12. That for her fear I have left Siliguri and again on my return she is threatening me to work with her as a prostitute and like this by showing me she has earned a lot of money which I came to know in Delhi when I received all the obscene phone calls.

I am constantly in the state of fear and my going out is also subjected to risk as has threatened me if I step out I will be kidnapped. And she has threatened my mother that if she again obstructed her (Rinki) then she will send goons to kill her. Please take immediate strict legal steps and action against her.
