**Subject: FIR**

Sir,

In producing herewith one arrested accused person namely Sankar Mahato (19 yrs) S/O Sarjug Mahato of Dakshin Palash Biswa Munda Math PS Pradhannagar Dist Darjeeling along with one seized vehicle bearing no- WGY 4905 (Truck) loaded with river bed materials under proper seizure.

I, SI Youel Lepcha (8116763588) S/O Jai Tshering Lepcha of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Sankar Mahato (19 yrs) S/O Sarjug Mahato of Dakshin Palash Biswa Munda Math PS Pradhannagar Dist Darjeeling along with one seized vehicle bearing no- WGY 4905 (Truck) loaded with river bed materials to the effect that today on 06/10/2023 I received a specific source information that one loaded vehicle bearing no- WGY 4905 (Truck) was coming from Debidanga Side towards Champasri under Pradhan Nagar PS, SPC under Pradhan Nagar PS.

Accordingly, I informed the matter to you and as per your kind order I along with ASI Manoj Kr Roy, Cv 242 Rakesh Mangar, CV 646 Baban Das left PS to verify the veracity of source information. On the way towards Debriding I detained the said Truck bearing no- WGY 4905 at Kadamgach Champasari on being asked the driver disclosed his identity as Sankar Mahato (19 yrs) S/O Sarjug Mahato of Dakshin Palash Biswa Munda Math PS Pradhannagar Dist Darjeeling

Accordingly, I seized the vehicle bearing no- WGY 4905 (Truck) and subsequently arrested the driver named Sankar Mahato (19 yrs.) S/O Sarjug Mahato of Dakshin Palash Biswa Munda Math PS Pradhannagar Dist Darjeeling. The whole process of seizure and arrest was made in between 21.15hrs to 21.45 hrs.

Hence, I pray that a specific case may kindly be started against the Sankar Mahato (19 yrs.) S/O Sarjug Mahato of Dakshin Palash Biswa Munda Math PS Pradhannagar Dist Darjeeling under proper section of Law and arrange for its investigation.
