

Sir.

I, ASI Manoj Kr. Roy of Pradhan Police Station, SPC would like to lodge this written complaint against one accused person named Malati Routh (48 yrs/F), W/O Lt. Ganesh Routh of Devidanga Bazar, PS- Pradhannagar, Dist. Darjeeling to the effect that today on 07.10.2023 evening I received a secret information that one lady has been selling and procuring illegal liquor at her residence at Devidanga Bazar under Pradhan Nagar PS without any valid licedse. Accordingly, I informed the matter to the I/C PS and diarised the matter in General Diary vide Pradhan Nagar PS GDE No 423, dated 07.10.23 and as per his kind direction myself along with CV/646 Baban Das and CV/242 Rakesh Mangar all of Pradhan Nagar PS had been to Debidanga Bazar under Pradhan Nagar PS to verify the veracity of source information. After arrival at Debidanga Bazar and as identified by the source conducted raid at the respective residence but seeing the police party the owner of the residence managed to fled away from the spot. Further being searched at the house the illicit liquor Eleven (11) bottles 60 UP Himalayan India made Liquor, each bottle contain 600 ml, each bottle MRP 155, (Total 6.6 Liters) marked as exhibit A out of which 01(one) bottle has been taken as sample for examination marked as exhibit A1 recovered from the said residence. Held local enquiry at it is learnt that one Namely Malati Routh is involved in selling and possessing of liquor without any valid license since long for her illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses. The whole process of seizure and label has been made in between 19.45 hrs to 20.30 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against Malati Routh (48Y/F), W/O Lt. Ganesh Routh of Devidanga Bazar, PS- Pradhannagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
