Sir,

I, Sri Dhiraj Ghosh, Son of Late Dharendra Nath Ghosh, resident of Gonsaipur, Post Office & Police Station - Bagdogra, District - Darjeeling, beg to lodge this complaint as under:

1. That since last 30 years, I have been running a tin shed office at Rupsingh Jote by the side of Asian Highway (near Phansidewa More, Commercial Check Post) within Police Station - Bagdogra, District - Darjeeling.
2. That today at about 10:30 a.m., I came to my said office and found that a signboard named "City Marbel" was installed touching the wall of my office and thereby created obstruction to me.
3. That on enquiry, I came to learn that Sri Subrata Roy, Son of Late Nirode Roy, the Prop. of City Marbel had done the said work of installation of the board of City Marbel.
4. That thereafter I requested said Sri Subrata Roy to remove the said board, but without paying any heed to my said requests Sri Subrata Roy, became furious and called his men and associates namely, Sri Bichitra Roy, Sri Rahul Roy, Sri Pankaj Goswami, Sri Pratul @ Chatul Sarkar and others, directing them to kill me.
5. That immediately said persons namely, Sri Bichitra Roy, Sri Rahul Roy, Sri Pankaj Goswami, Sri Pratul Sarkar and others started mercilessly beating me, with fist, blows and kicks and suddenly Sri Pankaj Goswami opened his Revolver and made an attempt to shoot me. I, on being scared, fled away and made a phone call to you at about 11:07 a.m. and after getting my call, police personnels came to the spot and I could somehow save my life.

You are, therefore, requested to enquire into the above matter and take immediate steps against the said miscreants/persons, after starting a specific case against them.
