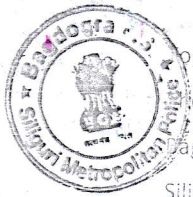

Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Samir Lama (42), S/o Lt. Moni Kumar Lama of Harekrishna pally PS PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Nine (09) nos of sealed Bottles of Kingfisher strong Premium beer, each bottle 650ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
2. Eighteen (18) nos of sealed Bottles of Kachi India made Liquor 70 up, each bottle 300 ml. Marked as Exhibit -B from which 01 bottles taken as sample for examination Marked as exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that today on 03.10.23 at 22-15 hrs. Myself along with C/351 Chandan Debnath, VP-02 Pradip Roy CV- 389 Janak Singh were performing evening Mobile duty vide Bagdogra PS GDE No. 139 dt. 03.10.23. At 22-25 hrs received a secrete source of information that one person was selling Id Liquor illegally from his house at Harekrishna pally to its customers without any valid license and the local people very annoyed against him. Accordingly I informed the matter to O.C. Bagdogra PS and as per his instruction myself along with force left for Harekrishna pally to verify the veracity of information. On arrival at the spot at 22-45 hrs it was found that one person mentioned above was selling liquor illegally from his house at Harekrishna pally to his designated customers to earn huge money for his livelihood desperately. On seeing the police party the customers as well as the seller tried to flee away, but the seller was apprehended by police. On being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses namely (1) Gaya Basfore (43) S/o Lt. Matuala Basfore of Suryanagar Tigerbustly PS Bagdogra Dist. Darjeeling and (2) Sanjoy Lama (34) S/o Lt. Prakash Lama of Railway Colony, Harekrishna pally PS Bagdogra Dist. Darjeeling I recovered (1) Nine (09) nos of sealed Bottles of Kingfisher strong Premium beer, each bottle 650ml and (2) Eighteen (18) nos of sealed Bottles of Kachi India made Liquor 70 up, each bottle 300 ml from the possession of the apprehended person from his house and seized the same as per proper seizure List and labeled duly signed by her and also witnesses. On being asked he failed to produce any valid document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 22-55 hrs and 23-25 hrs (seizure Total approx 11.2 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against the arrested female person namely Samir Lama (42), S/o Lt. Moni Kumar Lama of Harekrishna pally PS PS Bagdogra Dist. Darjeeling and arrange for its investigation.
