I Satakhi Ghosh, wife of Subhankar Ghosh, and daughter of Sampad Ghosh , resident of Mahananda para , Chandrapark near banprastha kalimandir, P.O. Siliuguri Bazar, P.S. Siliguri, Dist. Darjeeling, Pin- 734005 got married with Subhankar Ghosh, son of Dipak Ghosh, permanent resident of new town para, near primary school, P.O & P.S. Jaipaiguri, Dist. Jalpaiguri, Pin- 735101 and presently staying at Dhupguri fire-brigrade office barrack, Dhupguri, Dist. Jalpaiguri, which is his working place, on 29/01/2015. After few days of marriage 1)my husband Subhankar Ghosh, 2)my father-in-law Dipak Ghosh, 3)mother-in-law Shipra Ghosh, 4)brother-in-law Dipankar Ghosh @ tabu all of whom are resident of new town para, near primary school, P.O.& P.S. Jalpaiguri, Dist Jalpaiguri, Pin- 735101 started torturing me physically and mentally. Initially the torture was partaining to demand of dowry and quality of furniture's that was given as stridhan as per their demand. They stated that the quality of furniture was inferior and we must compensate them by paying cash. At the time of marriage my husband and my-in-laws demanded Rupees 2 Lakh( Rs. 2,00,000/- ) in cash as dowry. But my father could arrange only rupees 1 Lakh 50 Thousand ( Rs 1,50,000/- ) and that amount was given to them as dowry. However they compel me to pay them Rupees 60 thousand ( Rs. 60,000/- ) more as the balance amount with interst of dowry. This rupees Sixty thousand ( Rs. 60,000/-) was paid to them about after 1 year of marriage. After few days of marriage 1 came to know that my husband has an illicit relationship with one divorced lady namely

Moumita Das who is also a resident of Jalpaiguri . That affair started before my marriage. That lady Moumita Das herself call me and told me that my husband deeply loves her and I must leave my husband. When I asked my husband he told that it is his personal matter and I must not interfere in that and he being a man is free to have any illicit relationship. My parents-in-law and my brother-in-law physically assaulted me on any small pretext and they used to beat me merciliously. On 20/03/2017 a male child was born out of her wedlock. My child was detected with autism. My husband and my-in-laws fully blame me for my child's being autistic. That also they used to beat me now and then for giving birth to such a child. On 21/04/2022 I inform my parents about the torture as I could not bear it anymore and as I was apprehending danger to my life from my husband and in-laws. Immediately my parents and few other family members rushed to my matrimonial house and they sit together with my husband and in-laws to discuss about the tortures inflicted on me. But the matter did not settled their as my husband got furious seeing my parents there. On that night my husband beat me black and blue for informing my parents about the tortures they inflict upon me. Two days after that my husband left me and started living at barrack of fire - brigrade office at dhupguri of which his employee. At the time of living the house he told me and his parents that he would not step-in that house unless I live the house and his parents and brother ensure that I never came back again to their house. After that day he never came to meet me. From them on tortures upon me by my parents-in-law and brother-in-law increased many fold. Day and night they used to pester me to leave their house. Being threaten and by their attitude I have to sleep at night locking my door but my brother-in-law used knock at the door intermittently during the whole night and threaten me then I will have to face

5 07 on brutal consequences if I do not leave the house. Ultimately on 17/06/2023 my parents- in-laws and my brother-in-law thrown me and my child out of my matrimonial house and locked the door. Even though I resisted they did not let me enter the house. I am in deep mental shock and in a destitute condition with my child. Now my husband is continuously putting pressure upon me to divorce him and sign the mutual divorce papers he would bring, so that he could marry above-named Moumita Das. On 01/09/2023 at about 5. 30 PM when I was going to Jhankar More my husband, who was waiting there, confronted me and abused me in filthy language. He also slapped and inflicted few blows on me and threatened me to kill if I do not sign mutual divorce papers. As my father was admitted then at PG, Kolkata for medical treatment in serious condition, I did lodge any complaint then. Under the circumstances I humbly request you to treat the written complainant as F.I.R and initiate a case as per appropriate provision of law against 1) my husband Subhankar Ghosh, son of Dipak kumarr Ghosh, 2) Dipak kumar Ghosh, 3) Shipra Ghosh, wife of Dipak kumar Ghosg, 4] Dipankar Ghosh, son of Dipak Kumar Ghosh Thanking You Keecinal on 08/10/23 at 20;10 hx Yours faithfully vide siligmi momen por GOE M. 164 at 08/10/23 and started suigni Satakhi Oshosh
