1. That I am the authorized dealer of NISSAN MOTORS PVT. LTD in Siliguri.

2. That many spare parts are stocked in my workshop at the above noted address.

3. That dated 02/08/2023 I have noticed that some spare parts amounting to Rs. 3,55,226/- (Rupees Three Lakh Fifty Five Thousand Two Hundred Twenty Six) only were missing from my said stock in my above mentioned workshop.

4. That after enquiry it revealed from the C.C.T.V. footage that 2 (Two) unknown persons were stealing the said spare parts since last 2/3 days. Due to medical emergency, I was out of station for this reason I am submitting this letter on 08/10/2023.

5. That I am lodging this complaint today as I have assessed the amount of theft.

Under the above circumstances, it is therefore prayed before you to investigate the matter and to take strict legal action against the culprits and to also recover the said theft spare parts. Your kind and quick action is highly solicited.


