Sir,

With due respect, I Bhesraj Subba S/o Mangal Singh Subba, resident of Kalkut Devidanga, Lane No. -5, near Ganesh Mandir, PO- Champasari, Dist. Darjeeling would like to lodge a written complaint against some anti social miscreants who broke into my store house around midnight of **08.10.2023** and took away under- construction building materials including CCTV camera, DBR box (including hard disk) , JIO wifi box, Grills(2) of door and one iron window attached grill, and other miscellaneous items including iron rods, masonry items etc . That the estimate of the stolen items is estimated around thirty thousand rupees.

Furthermore, I would also like to bring to your kind notice that this is the second time that miscreants have broken into my house, wherein the first FIR regarding theft was lodged at your kind end on **24.09.2023**. However no such action or arrest was made till date.

Hence I would be very much grateful if your kind concerned authority would look into the above matters of theft and initiate steps to arrest those miscreants so that these kinds of incidents may not happen in the near future.
