SUB: COMPLAINT FOR ATTEMPT TO MURDER

I, Sri Nayan Haldar, S/O Late Pachkur Haldar, Resident of Adarshapally, Jaldomur Saho para, Kamarbhita, P.O Sahudangi, & P.S. Ambari, Dist: Jalpaiguri. Pin Code: 735135 would like to state that one Abhijeet Barman @ Bhutan resident of my locality i.e. Adarshapally, Jaldomur Saho para, Kamarbhita, P.O Sahudangi, & P.S. Ambari, Dist: Jalpaiguri. Pin Code: 735135 is a local goon. From many days in the past he has been disturbing my daughter namely Smt. Rani Haldar, D/o Sri. Nayan Haldar and has molested her on many occasions.

On the 7th October 2023 i.e. yesterday in the afternoon he forcefully tried to touch her in wrong places, outrage her modesty, grab and take my daughter. Somehow, I protested and was able to save my daughter. I took my daughter to one our relative's house and I kept her there. He threatened us that he would kill my entire family and then take my daughter for his pleasure.

At around 3pm or so I and my wife i.e. Mrs Anjana Haldar, w/o Sri. Nayan Haldar were alone at my house at Adarshapally, Jaldomur Saho para, Kamarbhita, P.O Sahudangi, & P.S. Ambari, Dist: Jalpaiguri. Pin Code: 735135. I was asleep and suddenly on hearing my wife shouting and crying in pain I woke up and rushed towards her. I saw Abhijeet Barman @ Bhutan pushing my wife against a wall and outraging her modesty, on being protested by my wife he mercilessly stabbed my wife with a Dau (Big Knife). My wife was on the floor and he was hitting her with it on her head with the dau/knife. He stabbed on her neck, hands, fists everywhere I could see was blood. I saw him stabbing my wife on her neck and she profusely started to bleed.

I hurriedly tried to stop, putting my life in danger. But I was beaten up badly, He using the deadly Dau/knife put a blow on my neck too, he tried to kill me by using the dau/knife on my stomach but somehow, I saved myself and the knife hit me on the side of my stomach. I was almost killed along with my wife only then the villagers and neighborhood people rushed in to save us. My son somehow arrived and took us to the hospital.

Today my wife is in a serious condition in the ICU in . Yesterday the entire day we were arranging for her medical facilities and admission procedures and hence I am writing this complaint now.

Abhijeet Borman a Hindu almost killed us both. He will come again and kill my entire family and take my daughter. Kindly take necessary steps and save us
