With due respect, I am producing herewith 01 (One) arrested accused person named Meheboob Khan (23), S/o- Raju Khan of Nipania, Fulbari, PS- NJP, Dist- Jalpaiguri under arrest. The ground of arrest duly been communicated with him and the following articles under seizure :-

- 01 (One) Improvised small fire arms one shooter measuring 23 cm in length (i) Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A".
- One live ammunition (loaded) marked as Exhibit-"B" (ii)

I, SI Shib Sankar Das of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 09.10.2023 during my special mobile van duty, at 19.05 hrs, I received a secret information, that one person came to Jatiakali More under New Jalpaiguri PS, Dist.- Jalpaiguri with improvised fire arms and ammunition to deliver the same to his designated customer. . Accordingly, I informed the matter to you and as per your direction, myself along with ASI-Khagen Barman, C/1044 Hari Kherwar, VP/13 Jamirul Islam all of NJP PS, SPC left for Jatiakali More under PS-New Jalpaiguri PS, Dist.- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Jatiakali More at about 19.25 hrs and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he was possessed improvised fire arms and ammunition. Hence, immediately, I searched the above noted detained person and found (i) 01 (One) Improvised small fire arms one shooter measuring 23 cm in length Approx including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as "Exhibit-"A" and (ii) One loaded live ammunition marked as Exhibit-"B". He exclusively possessed improvised fire arms and live ammunition illegally. On demand he failed to produce any document in support of the said improvised fire arms and live ammunition which has been found from his possession i. e. on his right waist . On further interrogation he stated that he came to Jatiakali More under New Jalpaiguri PS, Dist.- Jalpaiguri to deliver the same to his designated customer for his wrongful gain. Thus when his involvement in carrying and possessing illegal fire arms and live ammunition was established, I seized that improvised fire arms and 01 (One) round of live ammunition which was loaded in the fire arms under proper seizure list duly signed by him as well as by available witnesses. The whole processes of seizure and label was made in between 19.35 hrs to 20.05 hrs on 09.10.2023. . Accordingly, I arrested the apprehended accused person after issuing memo of arrest informing them about the ground of arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the accused person named Meheboob Khan (23), S/o- Raju Khan of Nipania, Fulbari, PS- NJP, Dist- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arms for sell purpose.

As he have willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Meheboob Khan (23), S/o- Raju Khan of Nipania, Fulbari, PS- NJP, Dist- Jalpaiguri under appropriate section of law and arrange for its investigation.
