Sir,

In producing herewith one arrested accused person namely (1) Ajay Ghosh @ puki (M/35yrs) S/O- Nitai Ghosh of Buddha Mandir road, Saratchandrapally, Ward No-40 PS Bhaktinagar Dist Jalpaiguri along with the following seized articles under seizure as per seizure list:

[i] 101 (one hundred one) grms of suspected to be Brown Sugar containing in a transparent plastic bag and marked as Exhibit- A

[ii] One (01) Black color Vivo Mobile phone having IMEI No- 860398069548557

I, Rantu Haldar s/o Monoranjan Haldar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 11.10.23 at 14:25 hrs, I received a reliable source input from Eastern Bypass near Bangla Bazar under Bhaktinagar PS that one person have possessed huge quantity of brown Sugar in his possession for delivering the same to his designed customers at Bhaktinagar PS area for his wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 569 dated 11.10.23 and subsequently, I informed the matter to the I/C Bhaktinagar PS,SPC in written and being directed, myself along with, PSI Chiranjit Saha, SI Mrinal Basunia, ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, all of Bhaktinagar PS with investigation kit left for Eastern Bypass near Bangla Bazar under PS- Bhaktinagar at about 14.40hrs by govt. vehicle to verify the veracity of the information vide Bhaktinagar PS GDE no. 570 dated 11.10.23 and M.C.C No- 1568/2023 Dated 11.10.23. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Eastern Bypass near Bangla Bazar at about 15.05hrs and meanwhile called two independent witnesses namely; (1) Diwas Limbu (M/37yrs) S/O- Man Bahadur Limbu of Bangla Bazar, Check post, Eastern Bypass, PS Bhaktinagar Dist Jalpaiguri (M-9361764373) and (2) Raj Kumar Pandit (M/45yrs) S/O- Ranjit Pandit of Raj Ellectronics, Bangla Bazar, Eastern Bypass, PS- Bhaktinagar Dist- Jalpaiguri (M-9832047924) and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being identified by source we detained one person and disclosed our identity and the information in hand and stated them that they will be searched in persons for the purpose. At this, he disclosing his name and address as noted above and admitted that he has illegally possessed brown sugar in his possession for selling the same to his designed customers as per requirement for their wrongful gain.

I then gave him written notice to be searched in presence of Spl. Executive Magistrate. Then he agreed to be searched in presence of Spl Executive magistrate. Accordingly, I informed the matter to Sri Shantunu Tarafdar, Assistant Commissioner of Police (A.P), SPC, as a Spl Executive Magistrate, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Eastern Bypass near Bangla Bazar under PS Bhaktinagar to remain present and to supervise the search and seizure.

Accordingly at 15.45 hrs Sri Shantunu Tarafdar, Assistant Commissioner of Police (A.P)/SPC, arrived at the spot as a Spl Executive Magistrate and subsequently, under his

supervision in presence of witnesses the process of search of the detained person for conducted following all formalities keeping his decency and recovered the above noted articles from the exclusive possession of above noted accused person. Subsequently, being demanded in presence of Sri Shantunu Tarafdar, Assistant Commissioner of Police (A.P)/SPC as a Spl Executive Magistrate the detained person failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 101 grams said to be Brown Sugar, Black color Vivo Mobile phone having IMEI No-860398069548557 which was kept inside right pant pocket of above noted accused person. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses from the exclusive possession of accused person. I also labeled and sealed all the articles under the supervision of Sri Shantunu Tarafdar, Assistant Commissioner of Police (A.P)/SPC as a Spl Executive Magistrate and witnesses and accused persons. The whole process of seizure was made in between 15.55hrs to 16.25hrs.

Being further asked, the apprehend person admitted in presence of Sri Shantunu Tarafdar, Assistant Commissioner of Police (A.P)/SPC and other witnesses that he procured the brown sugar clandestinely from Murshidabad for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means, he also disclosed that he have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused person after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the above noted accused person is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Nitai Chowdhury of Shivarampally, Haiderpara PS Bhaktinagar Dist Jalpaiguri.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the arrested accused person namely (1) Ajay Ghosh @ puki (M/35yrs) S/O- Nitai Ghosh of Buddha Mandir road, Saratchandra pally, Ward No-40 PS Bhaktinagar Dist Jalpaiguri also arrange for its investigation.
