Sir

In producing herewith following four accused namely i) Md Safikul @ takla (23) S/O Md Nur Islam of Ratan lal busty ward no 1 PS Pradhannagar Dist Darjeeling. ii) Kamal Roy (20yrs) S/O Lt Bablu Roy of Cooliepara ward PS Pradhannagar Dist Darjeeling. iii) Md Aktar (32) S/O majhaMuhamud of ratan lal busty ward no 01 PS Pradhan nagarDist Darjeeling. iv) Karan Subba(28yrs) S/O l Ganga Subba of Gurung busty near Ram Narayan Mat ward no 3 Ps Pradhan nagarDistDarjeeling along with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) recovered from the exclusive possession of accused Md Safikul @ takla
- 2) One iron made 'Knife' and one torch light recovered from the exclusive possession of accused Md Aktar
- 3) One iron made weapon called as 'Bhojali' recovered from the exclusive possession of accused Karan Subba
- 4) One small torch light from the exclusive possession of accused Kamal Roy

I, ASI Biplab Kr Dasof Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted i) Md Safikul @ takla (23) S/O Md Nur Islam of Ratan lal busty ward no 1 PS Pradhannagar Dist Darjeeling. ii) Kalam Roy (20yrs) S/O Lt Bablu Roy of Cooliepara ward PS Pradhannagar Dist Darjeeling. iii) Md Aktar (32) S/O majhaMuhamud of ratan lal busty ward no 01 PS Pradhan nagarDist Darjeeling. iv) Karan Subba(28yrs) S/O l Ganga Subba of Gurung busty near Ram Narayan Mat ward no 3 Ps Pradhan nagarDist Darjeelingand 8/9 others to the effect that today on 11/10/2023 at 00:05 hrs received a specific source information that 12/13 miscreants have assembled at Cooliepara near Mahananda river bed under PS- Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Gurung Busty area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide Pradhan Nagar PS GDE No 631/23 dated 11/10/2023 and as per order I along with SI Goutam Mallik , CV/645 Pankaj Gupta, CV/223 Swapan Chhetri CV/128 Ajoy Kumar Sahani, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger all of Pradhan Nagar PS, SPC, left for Cooliepara near Mahandnda River Bed to work out the information in hand. At about 00.35 hrs we arrived at Cooliepara near Mahandnda River Bed and as indicated by the source we noticed that 12/13 persons assembled at MahandaRiver Bed near Mukta Munch and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 04 (four) of them with deadly weapons in their possession but 08/09 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Bagha Jatin Colony area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made on 11/10/2023 in between 01.15hrs and 02.10 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons i) Md Safikul @ takla (23) S/O Md Nur Islam of Ratan lal busty ward no 1 PS Pradhannagar Dist Darjeeling. ii) Kamal Roy (20yrs) S/O Lt Bablu Roy of Cooliepara ward PS Pradhannagar Dist Darjeeling. iii) Md Aktar (32) S/O majhaMuhamud of ratan lal busty ward no 01 PS Pradhan nagarDist Darjeeling. iv) Karan Subba(28yrs) S/O l Ganga Subba of Gurung busty near Ram Narayan Mat ward no 3 Ps Pradhan nagarDist Darjeeling and others 12/13 unknown persons and arrange for its investigation.
