I Rohit Mahato Son, of Harindar Mahato, Residence of Chamrasari Pokhri, Jote, Ward no 46, would like to inform you that I was physically assaulted at around 9 PM at late night on 10.10.2023 by two people. As far as I remember one of them was Dhnanujy Mahato and other one was his relative. As I was going to fish market to collect some cash from my business associates I collected 17000, Rs (cash which I was carrying along with me. At time of returning from the market suddenly they came in front of my motor bike and started threatening me that whatever you have in your pocket just give us otherwise it will be not good for you. But during the period however I was able to survive from there but just after few minutes they both came with sum wooden sticks and iron rods and started charging on me, later I was totally injured however I was able to go for an treatment to a govt. hospital and was given emergency treatment over there. So I would like to lodge an General Diary against both of them. Later I didn't found my cash also.

I will be highly obliged, kindly do please grant my request.
