I Tehseen Parveen, wife of Md Ujjala, daughter of Md Taslim Rahaman, resident of Lower Bagdogra Masid Para, Bagdogra, P.S - Bagdogra Dist - Darjeeling would like to file a complaint against my husband Md UJJALA S/o - Rukhsana Khatun. Our marriage has solemnized on 23/05/2014 as per the Muslim rituals and customs. It was a love marriage and out of our wedlocks, we have two daughters namely 1. Shahar Khatun (8 years) 2. Humairah Khatun (3 years). Since the beginning of our marriage he started beating me and assaulting me using faulty languages as I didn't bring any money from my home. He used to demand money from my father as he is an unemployed and doesn't want to work for our livelihood. He is a habitual alcoholic because of it he always used to physically assault and did my character assassination for all silly small fights. Still I tried my best to live with him for the sake of my two daughters and out of love. However after my second daughter he has become more cruel and alcoholic that he drinks everyday and stay idly at home and demands me money. So I started working as a Security Guard in the Uttorayan but he always used to come at my work place and fight with me using all faulty languages

And it's been more than 2 years, I have been staying at my parental house but he always comes to our house as well as to my work place, KINS HOSPITAL at Sevoke, More, Jilgori and threats <sup>me</sup> of my life. He tried to ~~kill~~ ~~me~~ hurt me by his motorbike while walking on a lane many times. He comes to our place and fights with me and assaults me physically. I have been suffering a lot physically and mentally due to his cruel behaviour. So I have decided to file a complaint against him as the pain, I am going through is unbearable and I don't have any hope left on him.

So I kindly request you to do the needful as soon as possible.
