I Rinku Nath residential of Salugana, Siliguri, would like to lodge a complain against Mr. Kabul Pradhan, Mrs. Bina Pradhan, Mr. Anwar Ali, Mrs. Sarjina Parwin as all of them hit me very brutally at Bhanu Bhakta Chouk, Salbari Bazar.

Today around at 8:30 PM I got a call from one of my friend Mustak Islam, he told me over phone that he is not feeling well and was asking for help. Then I went to meet him at Gyan Jyoti More. he was not looking well then I decided to drop him at his own premises, after when we reach at Salbari, suddenly above mentioned named people came and started hitting me on my face, neck, <sup>scratching my</sup> hair and were also trying to tear my clothes. They snatched my gold chain along with a diamond locket. As well as they broke my scoty glass and took my keys with them, my scoty key was taken by Mr. Anwar Ali (Kazi Anarul Haque) all the people are from Mustak's family. Sir, all of them hit me very badly, I have many injuries on my body. Some local people were trying to handle the situation but they didn't stoped continuously hit me on open road. situation was out of control then Mustak shouted very badly on his family member and then my how arrange to start my vehicle with the help of some local people. as my scoty key's was taken by Mr. Anwar Ali. After a long struggle they started my scoty, then Mustak took me at siliguri Civil Hospital for emergency treatment hospital copy is attached for your reference (original copy enclosed). Pradhannagar Petroling van was also reached at the spot.

Sir, I humbly request you to kindly take a periar action against Mr. Kabul Pradhan, Mrs. Bina Pradhan, Mrs. Sarjina Parwin and Mr. Kazi Anarul Haque as they tortured me very badly, having so many wounds on my body, now I am sitting at your Police Station along with Mustak Islam, writing this FIR and pleading for justice.
