Sir,

This is to inform you that last night ( 11-10-2023 ) some miscreants has stolen away five (5) Nos. of iron grill ( approx. 25' ft. Length ) from the boundary wall of our transmitter complex, which came to the notice of Security Guard on duty today i.e. 12-10-23 at about 3.00 p.m. Such type of incidents have happended in earlier also.

The Medium Wave Transmitter complex is a vital installation of Govt. Of India and such incidents of theft may lead to major theft case in future disrupting the broadcast of programme of national interest.

It is requested to kindly look into the matter and frequent patrolling by police is very much needed, particularly during this upcoming festive season.

It is also informed that no. of Toto/Tata Magic vehicles are being parked infront of our main gate unauthorisedly, which poses a security risk to our installation. This may also be looked into.

This is for kind information and a fervent request to look into the matter so that such incidents may be averted in future.
