I, Smt. Asmita Chakraborty, Wife of Sri Kushal Bhattacharya, Resident of Deshbandhupara, Uday Shankar Sarani, P.O. Siligui Bazar, P.S. Siliguri, Dist. Darjeeling, West Bengal, Pin-734004. Sir, for your kind attention I want to inform you that, I am an Advocate by profession, presently practicing at Siliguri Court. That on 10.10.2023 at 9.18 p.m. while I was working in my chamber at Hakimpura, I got a sudden call from a phone number being 9749571185 which belongs to my client Sri. Partha Dasbairagya, Son of Nirmal Das Bairagya, who along with his wife Smt. Mousumi Pal, (both owners of Active Security Service at Rainbow Apartment, ground Floor, near Indian Gas Agency Shivmandir, Phansidewa more,) (both permanent resident of village Rajoor, P.S.- Ketugram, District- Burdhan, presently residing at Shivmandir, Bagdogra, P.S.- Bagdogra, District- Darjeeling, West Bengal, PIN-734013,) called me. As soon as I answered the said call the said Sri. Partha Dasbairagya, Son of Nirmal Das Bairagya, along with his wife stated that they will not pay my fees for conducting the bail of Sri. Partha Dasbairagya, Son of Nirmal Das Bairagya in connection with P.S Case No.5007 of 2023 U/S 379 of Indian Penal Code arising out of written complaint dated 21.09.2023 (being FIR No.715 of 2023) lodged at Kotwali police station by the Manager of M/S Good Will Tea & Industries Limited. When I enquired about the reason for such behavior, they started harassing, abusing and insulting me by using slangs and abusive languages stating "MAGGI BACHA TOKE DEKHE NIBO, TOKE MERE FELBO" for no particular reason. Not only this, they also

insulted me stating that I have no ability to move any hearing at Jalpaiguri court as I am not enrolled as an Advocate under Advocates Act, and lastly, they threatened me with dire consequences that they will kill me if I pursue them for my hard earned fees. Thereafter, when I left from my chamber at around 9.20 p.m I felt that someone was continuously following/stalking me till my residence. From the aforesaid conduct and gestures of Sri. Partha Dasbairagya and Smt. Mousumi Pal it is clearly apparent that the aforesaid couple have jointly and severally planned to harass me for their illegal gain and profit and hence I am under reasonable apprehension that they shall go to any extent to fulfill their illegal motives. I am currently under severe mental stress and trauma due to the aforesaid incident after coming to know about the intentions of the aforesaid couple and I have blocked them from all social media and messaging platforms. That due to the severe mental trauma, fear and anxiety, I could not file the present complaint on an earlier occasion.

It is my humble request before your good office to take necessary and quick action as soon as possible and book the aforesaid culprits namely, 1) Sri Partha Dasbairagya, son of Nirmal Das Bairagya, (having Ph No. 9749571185) and his wife 2) Smt. Mousumi Pal, wife of Sri Partha Dasbairagya, (having Ph No. 9749090660) under the appropriate provisions of law.
